### **On the Council Table** *Better Late Than Never!*



The City's Law Department, at the request of City Council and non-profit organizations, has drafted a proposed Community Benefits Agreement (CBA) ordinance. The proposed ordinance would require negotiation, monitoring and enforcement of CBAs for certain development projects, provide for the utilization of Detroit Employment Solutions Corporation for hiring and training residents, provide

for the contracting of Detroit-based businesses, ensure environmentally sound and sustainable practices and provide for Homeowner and Tenant Relocation programs. We need to ensure that those who wish to do business in Detroit, do business with ***Detroiters.***

### ***S.A.D. but it's True!***

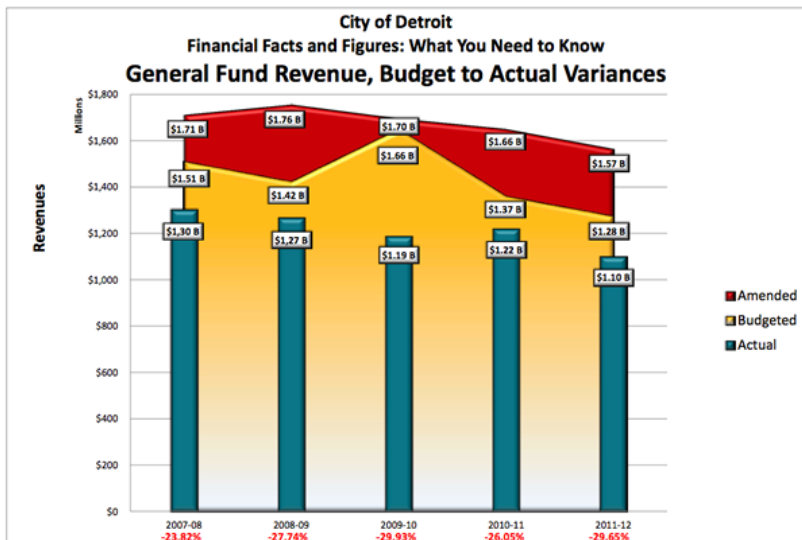


City Council, by a unanimous vote, approved the ordinance which enables neighborhoods to establish Special Assessment Districts (SADs) for financing snow removal from streets, mosquito abatement, and increased security services. As written, the ordinance will require the establishment of a Designated Neighborhood Improvement Organization (DNIO) which, in turn, can petition the community it serves to establish a SAD. The City of Detroit will facilitate the assessment, collection and purchasing of services under the direction of an established DNIO.

### ***The Bottom Line is....***



The Mayor transmitted to Council a triennial budget, as required by the City Charter, covering Fiscal Years 2015 through 2017. Notable changes include variations to the Community Development Block Grant (CDBG) funding process, extreme reductions to employee benefits across virtually all departments and funding of restructuring and reinvestment initiatives associated with the City's Plan of Adjustment filed with the Federal Bankruptcy Court. During the budget process for CDBG, Councilwoman Sheffield was able to restore grant funding to the world-renowned arts group, Mosaic Youth Theatre of Detroit.

## Keeping Up with the Councilwoman *Touching the District!*



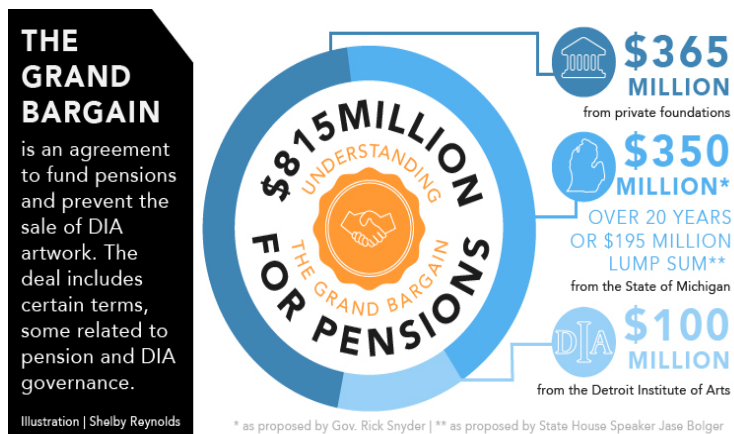

## Telling Our Story!

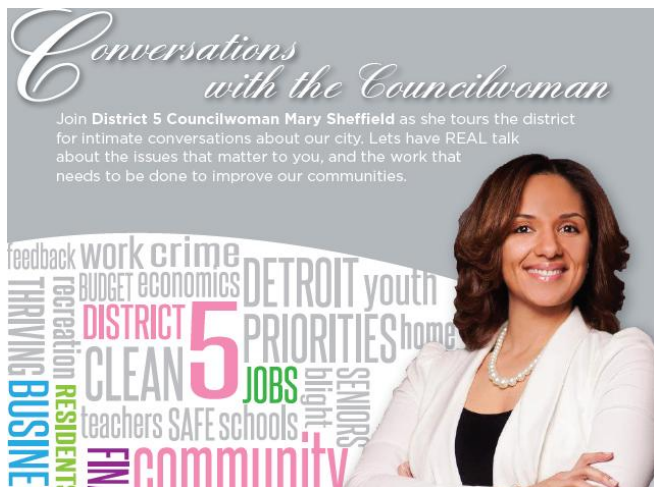


Council Member Sheffield accompanied her colleagues and the Mayor in Lansing to provide testimony on the package of bills known as the "Grand Bargain." Although, Council Member Sheffield was there in solidarity with other City officials to protect retirees' pensions, she had serious concerns and reservations about House Bill 5566 (the main bill). She was not in support of a 20 year oversight period and had reservations about relinquishing control of such a valuable asset such as the DIA collection. With that said, City Officials and Detroit State Legislators were successful in achieving key amendments, such as an appointment for the Council President and a provision which would cause the commission to go dormant after 3 years, instead of 10, if the city meets required financial benchmarks.

On Tuesday, June 10, 2014 at 6pm in the 13th Floor CAYMAC Auditorium, there will be a public hearing on the proposed Detroit Water and Sewage Department rate increases. The two major factors contributing to a need for an increase are: lower sales volume trends and increased retail bad debt expenses. The proposed rate increase is designed to generate 0.4% more revenue for water and 0.5% less revenue for sewage. Come and let your voice be heard on this important issue.
