Hosea Williamson-Accommodation Request cont.: Ms. Novo stated that at Local 58, if you have a problem taking the exam, sometimes the applicant is slotted back into the Apprenticeship program so he/she can be helped with the skills in which they are lacking. After deliberation, Mr. Litt made a motion to approve the extension of time requested. The motion was seconded by Mr. Coklow. Motion carried. A certified letter will be sent to Mr. Williamson of the Board's decision.

Ms. Novo was asked to tell the Board a little about herself. Ms. Novo stated she went through IBEW Local 58 in 1994, took the Journeyman exam in 2000, and worked through various contractors including Henderson Electric, Motor City, Superior Electric, and Micron Electric. Ms. Novo has also worked out of state including Las Vegas, Utah, Pennsylvania, Massachusetts, and New York.

There have been a couple of Apprentice applications that have been submitted to the Board with letters of employment dated 4-5 months before submission to the Board. This poses a couple of concerns:

- 1. Apprentices are required to register 30 days from employment.
- 2. The applicant may have been employed 4-5 months ago, but is she/he employed now.

Mr. McAlister feels that there should be a definitive time line that the Board looks at the letters submitted. There should be a reasonable time frame that the Board can accept the letter(s) of experience as being valid. Mr. McAlister suggested a maximum of 90 days of application and then asked Mr. Capers for input from the Department's view. Mr. Capers stated that 90 days is fine, although sometimes applicants have an issue submitting their application due to their work schedule(s).

Letters of Experience for Electrical Apprentices cont:

Mr. Litt suggested when there is an applicant submitting a letter with a disparity in time, the Board sends a letter for the applicant to offer an explanation with a due date for the explanation.

After further discussion, Mr. Litt made a motion that letters of experience from Electrical Apprentices be dated no later than 90 days from submission of their application to the Board. Mr. Capers stated that the 90 day time limit is fine, but when the letter is rejected, the Board should notify the applicant that he/she now have 30 days in which to re-submit their application to the Board with the corrected letter. The motion was seconded by Mr. Coklow, Motion carried.

UNFINISHED BUSINESS CONT.

- **Board Mission Statement:** Mr. McAlister proposed that the language *Electrical Inspection Supervisor* be changed to *Electrical Inspection Division*. Mr. Litt made a motion to amend the Mission Statement as stated by Mr. McAlister. Mr. Brown seconded the motion. **Motion carried.**
- Revision of "In Honored Memory" for Jimmi Smith: Mr. McAlister has emailed Mrs. Smith regarding approval of the draft, but she has not responded.
- Electrical Newsletter Article: "About the Board": After reviewing the latest draft, Mr. Litt made a motion to approve the draft. Mr. Coklow seconded the motion. Motion carried.
- Proceedings of the 1999 ASME/IEEE Joint Railroad Conference: M1 Rail Project: Mr. Brown submitted the abovementioned document at the December 18, 2014 meeting as reference for discussion regarding the M1 Rail. Mr. Brown asked Mr. Capers if the City has done any inspections in regard to the M1 Rail. Mr. Capers stated that to the best of his knowledge no inspections have been performed. Mr. Coklow inquired why haven't there been any inspections performed? Mr. Capers stated this question would have to be put to his supervisor, Mr. Glenn Davis, Chief of Construction, and/or the Deputy Director of BSEED, Mr. David Bell.

 Mr. Litt asked if any drawings are being presented to Plan Review. Mr. Capers stated

Mr. Litt asked if any drawings are being presented to Plan Review. Mr. Capers stated that he will call the Electrical Plan Reviewer, Mr. Vincent Cooley, to find out. Mr. McAlister asked have there been any investigations as to this project by the Electrical Division? Mr. Capers stated that it has been made known to him that there has and is concealment without benefit of inspection, and one of his inspectors, Mr. Anthony Campbell, did go out to perform an inspection, but when he arrived at the site no one would provide Mr. Campbell with their name, or provide proof of licensure when asked. Mr. Litt asked what would be more effective, sending a letter to the Building Contractor or BSEED's executives pointing out the Board's grave concern. Mr. Capers stated it would be more appropriate to address BSEED's Administration to find out the status, as far as, inspections being made, and how to proceed.

Now that the December minutes are approved, the letter mentioned in last month's meeting will go out to the Director of BSEED, Mr. Eric Jones, expressing the Board's concern about the M1 Rail.

- Administrative Rules Revision: Ordinance 604-H Section 406.0: The revisions proposed for Sec. 406.0 were presented to the Board this month. However, the draft provided was not the latest version. The correct version will be presented at the February meeting for discussion Mr. McAlister proposed that the new members to be added to the Board be voted on one by one. The Board agreed.
 - 1. One representative of the Fire Marshal's Office. Mr. Litt made a motion to appoint one representative to the Board as a voting member. The motion was seconded by Mr. Brown. Motion carried.
 - 2. One representative who shall be a Licensed Contractor whose principle occupation is low voltage, electric signs, fire alarm installations, or Sign Specialty. Mr. Litt inquired how much does a sign contractor get involved with the electrical aspect? Mr. McAlister deferred to Mr. Capers. Mr. Capers stated a Sign Contractor can pull an electrical permit. After reviewing Public Act 217, a sign contractor can work on the sign circuit that is existing or extended from where an Electrical Contractor leaves a junction box for the Sign Contractor. After further discussion, Mr. Litt made a motion to appoint one representative who shall be a voting member who is a licensed contractor whose principle occupation is Fire Alarm and/or Low Voltage installations only. The motion was seconded by Mr. Brown. Motion carried.
 - 3. One representative of distributors of electrical apparatus and/or supplies (i.e. a vendor, a supply house). After discussion, Mr. McAlister made a motion to appoint one representative as a non-voting member. The motion was seconded by Mr. Litt. Motion carried.
 - 4. A representative of manufacturers primarily and actively engaged in producing material fittings, devices, appliances, fixtures, apparatus, and similar products used as part of, or in connection with, an electrical installation. After discussion, Mr. Litt made a motion to appoint one representative as a non-voting member. The motion was seconded by Mr. Brown. Motion carried.
 - Mr. McAlister stated he will try to speak with Mr. Wayne Robinson, Chief, Property Maintenance Division, today. Mr. Robinson is the coordinator for all revisions of the Ordinances and Acts for BSEED. Mr. McAlister will present an update of that discussion at next month's meeting.

Mr. Litt made a motion to send the letter in the event that Ms. Ortiz does not respond in a timely manner. The motion was seconded by Ms. Swint. Motion carried.
