UNFINISHED BUSINESS CONT.

- BSEED's Website: The Board was able to take a look at the revamped City of Detroit website. This site is based on the premise of "How Do I?" Mr. Preuss brought forth the issue of checking via the website for validating Electrician Registrations/Licenses. After discussion, Mr. Litt made a motion to send a letter to the appropriate authority indicating the Board's concern about the difficulty of ascertaining whether Journeyman are currently licensed. Mr. Preuss suggested an amendment to the motion to include all electricians. Motion carried. After review of the new site, Mr. McAlister voiced his concerns about the site and suggested it should be addressed. Mr. Preuss seconded Mr. McAlister's concerns. For example, the Access for All program information is posted under the "Education" icon for all trade Licenses. At present, the City's ITS Department (Information Technology Services Division) is in the process of transferring the pages from the old website and inserting them onto the new site. Ms. Swint stated that she will review the new site and start working on the Electrical Division information. At present, the Board is not on the new site, but ITS is aware of this issue, and will be transferring the Board's information to new site soon. The Secretary also encouraged the Board to take a look at the new site and inform her of any changes/edits they would like to suggest. Mr. McAlister stated he would like to send a letter to the appropriate authority expressing the Board's concern of the inaccurate and confusing new site. Ms. Swint suggested that the Board allow her time to tool around the website and see what can be done. If at that time, the letter is needed it will be sent out to the appropriate person. Unanimous Decision.
- Board's Administrative Rules: Review of Ordinance 604-H, Section 406.0: Mr. Capers and Ms. Swint discussed the adoption of the revised Ordinance with Mr. Dennis Muzurek, City Clerk's Office, who is in charge of making sure the whole of the City of Detroit's Code is updated and available to go online for the public. In speaking with Mr. Muzurek, the whole of Ordinance 604-H must be updated not just one Section. Mr. Muzurek plans to present all revisions to City Council for approval on June 15, 2015 with an anticipated date of adoption on July 15, 2015.
- M1 Rail Project: Mr. Eric Jones, Director of BSEED, was sent a letter by the Board regarding the concerns of the project proceeding without benefit of trade inspections. Ms. Swint stated that she cc Mr. Davis and Mr. Bell, and was told by Mr. Davis that MDOT is responsible for inspections for the M1 Rail. Ms. Swint stated that she responded to Mr. Davis by stating a member of the Board clearly stated that MDOT was not going to take responsibility for the M1 Rail within certain City limits.

- M1 Rail Project Mr. Capers stated that no one has addressed him about said letter, but Mr. Bell indicated that the right-of-way is not private property and therefore will require inspections, and asked Mr. Capers if he was in agreement. Mr. Capers stated to Mr. Bell that this decision would have to made by the Director. Mr. Bell stated he would get back to Mr. Capers. Mr. Preuss made a motion to send an invitation to Mr. Jones to attend March's Board meeting in order to respond to the letter regarding the M1 Rail. Mr. Litt seconded the motion. Motion carried. Mr. Cronk suggested the Board have materials and/or any information ready to present to the Director. Mr. Preuss re-stated that MDOT stated they cannot inspect anything south of Adams Street in the City of Detroit, and the M1 Rail is a privately owned and self-contained project that does not require inspections from them. Mr. Preuss suggested that Mr. McAlister speak with Mr. O'Donnell about the project and his take on this issue.
- In Honored Memory, Jimmi Smith Obituary: Mrs. Smith has not responded to Mr. McAlister. The Board will move ahead with putting the obituary piece in the newsletter.
- Apprentice Coordinator Forum Update: The auditorium has been booked for Wednesday April 15, 2015 for the forum. Some issues to be discussed: 90 day limit for Apprentice work experience letters, Mr. McAlister posed a question: When working in a plant- How is the municipality aware if a Master Electrician is present? Mr. Capers stated there is the Owner's Affidavit, but of course not everyone applies for said document. Mr. McAlister asked if the Department could draft a list of the Owner Affidavit employers for invitation to the forum. Mr. McAlister stated he will reach out to Mr. O'Donnell, Chief of the State of Michigan Electrical Division, to find out their requirements for Owner's Affidavits. Other issues, documentation of education and making sure courses are approved, and minimum hours/year are maintained. Mr. McAlister stated the Powerpoint presentation is basically done, but has to be tweaked to include the above issues. Mr. McAlister will also email the Board the presentation to view and for feedback.
- Electrical Division Newsletter Review: This will be tabled to the March meeting.
- Apprentice Residency Update: As part of the development agreement between Olympia Development Management and Detroit City Council there has to be a certain percentage of Detroit residents hired. There is a concern that applicants will simply go to the Secretary of State to change their address in order to circumvent the residency requirement. Ms. Swint stated that these new requirements put forth by Olympia would have to be approved by the Director of BSEED. Mr. McAlister suggested that this issue be put forth to Mr. Jones when he attend the next Board meeting. Unanimous decision.
