#### <u>UNFINISHED BUSINESS</u>

Mr. Brown has submitted further revisions of the board's by-laws for review. A quorum will consist of the majority of the composition of the board.

#### **NEW BUSINESS**

• Public Act 407 Skilled Trades Regulation Act: On May 3, 2017 the Reciprocal Council held an Act 54 continuing education meeting at the Ukrainian Cultural Center in which the Chief of the State of Michigan Electrical Division, Dean Austin, spoke about the significant changes in the new abovementioned Public Act, adopted April 4, 2017, which supersedes Public Act 217.

## Some of these changes include:

- 1. Issuance of Temporary Licenses
- 2. Higher disciplinary punitive fees
- 3. Renewal of licenses-If a licensed electrician has not renewed by January first of the new year, he/she is no longer a licensed electrician, and is subject to fines as outlined in the Act.

However, *Article 7* of the Act does not apply to the City of Detroit nor the City of Grand Rapids, which are their own licensing entities. Mr. McAlister suggested speaking with the Director of BSEED, David Bell, to discuss the board establishing satellite locations in the city in which to discuss the ramifications of the new public act with licensees, and send out notification to electricians regarding the act. Mr. Bell was invited to this month's meeting, but he had a scheduling conflict. Mr.Bell indicated if he was able, he would try to attend the meeting. If Mr. Bell is unable to make it this month, Mr. Bell will be invited to the June meeting. Mr. Litt made a motion for the board to get the appropriate permission from Mr. Bell to notify citizens of the changes in the new public act. Unanimous Decision. **Motion Carried.** 

- Mr. Brown intends on retiring from DTE Energy in March of 2018, and has a gentleman to recommend as a replacement: Mr. Don Deachin.
- Mr. Brown also asked to be excused from next month's meeting, he will be unavailable to attend.
