UNFINISHED BUSINESS

• Apprentice Coordinator Forum Update: In attempting to speak with Mr. O'Donnell on April 7, 2015, Mr. McAlister spoke with Dawn Smith of the Electrical Division about the Board's forum and asked about the State's process regarding Apprentice Registrations. Ms. Smith handles the Apprentice applications that are submitted to the State for Registration. When asked about the problems that the Board experienced, she echoed the same issues. What is the State's process for resolution of these issues? She stated they make a phone call to the employer to verify what is deficient on the application.

Also, Ms. Smith informed Mr. McAlister that the Attorney General has interpreted *Public Act 217* to mean Apprentice Registrations and Journeyman exam requirements are two separate entities. According to the Attorney General's interpretation, the law only speaks to the requirement for the 8,000 hours of work experience, and does not speak to the applicant requiring Apprentice Registrations when applying for his/her Journeyman exam. Therefore, when applicants apply for the Journeyman exam to the State's Electrical Division, their Division may no longer look at the applicant's Apprentice Registration history.

Mr. McAlister and Ms. Swint spoke with Mr. Dan O'Donnell, Chief, State of Michigan Electrical Division, on April 8, 2015. Mr. O'Donnell confirmed the information that was given to Mr. McAlister by Ms. Smith. Mr. O'Donnell stated on advice from legal counsel and his administration, Apprentice Registrations are no longer a factor in Journeyman licensure. The State was requiring four years of Apprenticeship until 2011, then were told to stop doing so. This direction by the Attorney General was not given to the State Electrical Division in writing, but communicated via the Division's Administration.

UNFINISHED BUSINESS CONT.

Apprentice Coordinator Forum Update cont.: Does this requirement apply to the City of Detroit? Mr. O'Donnell recommended that the City of Detroit Electrical Division consult with the City's Law Department regarding this issue. The PowerPoint presentation for the Apprentice Forum scheduled for Tuesday, June 2, 2015 at DTE Energy was viewed and discussed.

- Apprentice Residency Update: This matter will be tabled for the May meeting.
- Traveling Electricians: During the discussion with Mr. O'Donnell on April 8th, he stated there is a big influx of electricians in the State, specifically Lansing. The requirement for travelers/out-of state applicants are they are not considered a licensed person. They would have to register as an Apprentice. If the applicant was a Journeyman or Master electrician in their state, the applicant may qualify for examination upon a determination by the Board that the license was obtained by the person through substantially the same or equal requirements as those of the State of Michigan. Or, if the applicant can show documentation that qualifies them, then the applicant can obtain a temporary Journeyman License for a period of not more than 90 days (without testing).
- M1 Rail: Mr. Preuss stated the M1 Rail has an Electrical Contractor: DES (Detroit Electrical Services). An invitation will be sent to the Director, Mr. Eric Jones, for the May meeting. The Board has not yet received a response from its February letter to Mr. Jones regarding inspections of the M1 Rail.
- Arc Fault Protection: The 2012 Michigan Residential Code that purportedly will eliminate the requirement of arc fault protection will not be adopted at this time.
