UNFINISHED BUSINESS

- House Bill 4813: Mr. Litt suggested sending another letter, due to lack of response from the lawmakers, proposing that due to the suggested rise in the Apprentice ratio, the Apprentices will not have enough experience or exposure with the Master electrician, and need to be Apprentices longer. After further discussion, a letter will be sent to various groups in the industry that have an interest/concern soliciting support, and if support is given then it can go to the next step. Mr. Litt and Mr. Preuss will work together to draft the letter.
- BSEED Special Meeting Request: The secretary contacted the Interim Director's assistant Ms. Ortiz twice, to arrange the meeting with the Interim Director, David Bell, and he has been unavailable. Glenn Davis indicated he would contact Mr. Preuss regarding this issue (see January 21, 2016 minutes). To date, Mr. Preuss has not received a response from Mr. Davis. During the meeting, Mr. Preuss had a chance to talk to Glenn Davis. Mr. Davis informed Mr. Preuss that a request to Human Resources regarding new electrical inspectors has been submitted, and it doesn't look like the job announcement forthcoming, and Olympia Entertainment is requesting two full time inspectors for the arena.
- **2009** *Michigan Residential Code* (MRC): A letter regarding the support of having arc fault protection in one and two family dwellings is still in progress.

NEW BUSINESS

- **Reciprocal Council:** Mr. McAlister will have a presentation in April on the City of Detroit's Plan Review process, and he will be representing himself as a member of the Board, so if the Board chooses, Mr. McAlister will show the presentation to the Board.
- While doing research on this presentation i.e. how other communities do their Plan Review process, Mr. McAlister discovered that the City of Seattle has traffic management systems as part of their code, as well as, light rail systems. This is covered under Part 80 of their Code. Inspections are done in conjunction with the Washington State Department of Transportation. Mr. McAlister will call the City of Seattle and try to find out more information in regard to this issue.
- The Michigan Public Safety Commission has made a significant change for service: All new, relocated, or upgraded residential service connections will be installed as underground residential service laterals at the customer's expense as set forth in Section C6.4 (see January 21, 2016 minutes for attachment)
