BOARD HEARINGS/CONSIDERATIONS (CONT.):

The Chairman offered some electrical licensing history: In the late 90's, one of the City of Detroit mayoral candidates, as part of their platform, stated that Detroit would keep its electrical licensing, which the City did, and the state mandated the city would have to follow

the state's guidelines.

The chairman stated that he does not see any duplication in electrical licensing. Either you receive a license through the City of Detroit, City of Grand Rapids, or the State, and there aren't any additional requirements to take another exam if you perform work elsewhere in the state. The Electrical Contractor Registration requirement is not uncommon throughout the state. It gives the local community a way of supervising the electrical contractor while performing work in that municipality. The only duplication that may be seen, is the issue of the Certificate of Fitness issued through the City of Detroit Fire Marshal Department. Electrical contractors feel that if they alreay possess a Fire Alarm Contractor's License or Electrical Contractor's License, this certificate is not needed.

Mr. Brown stated that the Board should prepare arguments in case the question comes before the Board.

Mr. Preuss stated that a previous electrical inspector, John McFeely, was adamant that the City of Detroit be the gold standard. With Detroit being the largest city and heavily industrialized, it was in the City's best interest to have its' own sovereignty in regards to licensing and enforcement, and be above politically driven agendas. Politics should not drive the safety of our citizens.

Mr. Taylor made a motion: Keep the electrical examinations in place with an added focus to use them as a prerequisite for mentorship programs in the City, as well as, ensure Detroiters

are treated fairly in the licensing process.

Mr. Preuss questioned Mr. Taylor on the aspects of implementation. Mr. Taylor stated that in terms of a mentorship program that the Board has previously discussed, it is implemented in a way that would be for Detroit residents, and would require city licensure. **Motion Carried.**

UNFINISHED BUSINESS (CONT.)

- **Board By-Laws-** Last month Mr. Brown was asked to prepare documentation to present regarding by-laws. Mr. Brown took the by-laws from another City Board and began to modify them to be consistent with *Ordinance 604-H*. After discussion, Mr. Brown will continue his modifications and will focus on procedural aspects and concerns that are not addressed by the ordinance.
- 2015 Michigan Residential Code-Arc Fault Letter: The Board is still waiting for the revision from Glenn Davis. Should the Board proceed without his revision? After discussion, Mr. Litt made a motion: The Board should send the letter without Glenn Davis' revision in lack of his response of our request to expedite his answer, we feel obligated to move forward. Motion lost after debate. Mr. Taylor made a motion: Send Glenn Davis a notice that this matter will be an Agenda item and the Board formerly requests his presence at the next scheduled meeting. The Board will be obligated to move further if his input is not received in pursuant of the Agenda item. Motion Carried.

- **Proposed Apprentice Forum:** Should the Board have another Apprentice forum in 2017? Mr. Preuss made a motion: The Board should present another outreach session with a target date of March 2017 to current and future electrical workers and contractors. **Motion Carried.**
