#### **Process Overview**

#### **OPEN ENROLLMENT**

SIGN ME UP!

- Applications accepted 11/18/2017 12/15/2017
- · Apply online or in person.

#### **DELRAY SCORE**

- The Delray Scoring System defines the participants' placement within the program.
- This score was developed by the Community Advisory Group (CAG) of the Southwest Detroit Community Benefits Coalition.





#### **MATCH PERIOD**

- First batch of homes are available for viewing for accepted participants in the program.
- Attend neighborhood meet and greets and open houses.
- Work with BNP Housing Consultants to understand the home swap process.

#### **Process Overview**

#### **CHOOSE YOUR HOME**

- · Rank your home choices.
- · Select interior home features.
- · Sign your BNP Swap Agreement.





#### CONSTRUCTION

- · Construction begins on your new home.
- Construction is expected to take anywhere between 6-9 months.

#### **MOVE IN**

- You and your BNP Housing Consultant will take a final walk through & inspect your new home.
- You will sign all your closing documents and take possession of your new home!



#### **Program Updates**

- 1. Program Interest During our first open enrollment 57 people applied. This was almost triple the amount we expected.
- **2. Delray Score** -Your Delray Scores is based on where you live, how long you have lived there and existing health conditions for anyone living in the home.
- **3. Composite Scoring** -Your Composite Score is your Delray Score ranked in order based on the date your application was marked as complete.
- **4. All applicants will participate in Round 1**. There will be multiple rounds. Ten homes will be offered in Round 1.

### **Program Updates**

The Bridging Neighborhoods Home Swap Program requires that each participant:

- ✓ Be current on all property taxes by the time the Swap Agreement is signed.
- ✓ Be current with the Detroit Water and Sewage Department on all water and sewage accounts by the time the Swap Agreement is signed.
- ✓ Participate in a home preservation workshop.

Early Fall 2018 - Walk-Through Inspections & Closings






