Office of Inspector General Debars former City Contractor Environmental Specialty Services Inc. and Richard Berg

DETROIT – On April 7, 2020, the Office of Inspector General (OIG) issued its Final Determination of Debarment of Environmental Specialty Services (ESS) and Richard Berg (Representative of ESS). The debarments are effective as of September 20, 2019. ESS and Richard Berg are each debarred for 20 years.

On April 23, 2019, the OIG initiated an investigation into the alleged criminal activity of ESS and Mr. Richard Berg, which was predicated on an investigation completed by special agents of the Special Inspector General for the Troubled Asset Relief Program (SIGTARP). The SIGTARP investigation resulted in the guilty pleas of Aradondo Haskins and Anthony DaGuanno. “There is no place for bribery that hurts competition in the Hardest Hit Fund’s blight demolition program,” said Christy Goldsmith Romero, Special Inspector General for TARP. “We commend Detroit IG Ha, and IG attorney Jennifer Bentley on taking strong action that protects the HHF program in Detroit.”

Court records and other information indicated that Richard Berg bribed Mr. Haskins on behalf of ESS while Mr. Haskins was an employee of the Detroit Building Authority (DBA). Mr. DaGuanno, a now former Adamo Group (Adamo) employee, received bribes from ESS in exchange for helping the contractor ensure that it could submit a lower bid. It was the determination of our Office that ESS did not take adequate actions to address Mr. Berg’s conduct and prove its intent to be a responsible contractor moving forward.

The Debarment Ordinance allows companies and individuals to appeal the debarment determination to Detroit City Council. The aforementioned company and individual chose not to appeal the OIG’s determination of debarment to City Council.
