Before your Honorable Body is the FY 2019-2020 budget amendment that was recently presented to you by the Office of Chief Financial Officer (OCFO) to address the projected \$154.0 million revenue shortfall for FY 2019-2020 as a result of the Coronavirus (COVID-19) pandemic. Attachment I represents the FY 2019-2020 Budget Amendment.

Parenthetically, City Council will recall that the City of Detroit is currently facing a projected \$348 million revenue shortfall for both FY 2020 and FY 2021 due to the COVID-19 pandemic: \$154.0 million for FY 2020 and \$194.1 million for FY 2021. Attachment II shows the proposed budget solutions for the FY 2020 and FY 2021 revenue shortfalls.

It is important to note that the Legislative Policy Division (LPD) reviewed the assumptions made by the OCFO to derive the projected \$348 million revenue shortfall, and we feel the assumptions are reasonable. It is also important to remind your Honorable Body that you approved an Errata Letter during the FY 2021 budget process that addressed the estimated FY 2021 \$194.1 million revenue shortfall on Tuesday, May 5, 2020.

Due to the import of the FY 2019-2020 budget amendment, LPD took a considerable amount of time reviewing the document with Office of Budget representatives of the OCFO. Council will recall that during the FY 2021 budget process, the Office of Budget anticipated a \$154.0 revenue shortfall for FY 2020. Now, almost two months later, the Office of Budget still anticipates a \$154.0 million shortfall since there are no signs that the revenue shortfall has increased during this lapse of time. Based on LPD's independent review of general fund revenue trends through June 2020, we feel that the Office of Budget's assumption that the FY 2020 \$154.0 million revenue shortfall has not increased is reasonable.

On pages 4 through 6 of 6 of the resolution component of the FY 2019-2020 Budget Amendment, City Council is asked by the OCFO to approve the increase and decrease of appropriations to the FY 2019-2020 budget to maintain a balanced budget and address the projected \$154.0 million revenue shortfall for FY 2019-2020.

Since City Council votes by appropriation regarding the City's budget, it was important to LPD to understand why the net (\$93.5 million) change to revenue and expenditure appropriations that did not agree with the \$154.0 million revenue shortfall figure. We subsequently found out that the net (\$93.5 million) change to revenues included other revenue budget changes as follows:

LPD is now comfortable with this reconciliation.

In addition, LPD tied the revenue and expenditure appropriation changes based on the above figures to the more detailed supporting schedules provided by the Office of Budget for LPD's review. Attachment III represent more detailed supporting schedules from the Office of Budget. Using various spreadsheet iterations created by both LPD and the OCFO, we are now comfortable that the figures your Honorable Body will be voting on sufficiently tie to the supporting more detailed schedules.

Re: Fiscal Year 2019-2020 Budget Amendment

The OCFO - Office of Budget requests authorization to amend the City of Detroit Fiscal Year 2019-2020 Budget to maintain a balanced budget, as required by the Uniform Budgeting and Accounting Act, 1968 PA 2, MCL 141.421 to 141.440.

Due to the Coronavirus Disease 2019 (COVID-19) public health emergency and its mandatory business closures and impact on the national economy, the Office of Budget is projecting a \$154 million revenue shortfall in Fiscal Year 2019-2020 driven by:

- Gaming revenue losses directly tied to the casino closures on March 16, 2020
- Income tax reduction as employers have laid off and furloughed workers and there is a forecasted contraction in the national and state economy
- Anticipated State Revenue Sharing reduction due to a drop in state sales taxes
- Other revenue losses from suspended parking enforcement, bus fare interruption to protect drivers from COVID-19 and a reduction in business and construction permitting activity

The City has taken decisive actions to address the revenue shortfall:

- In early March, the Chief Financial Officer canceled all cash capital projects that were not yet under construction and all demolitions that were not an urgent life safety matter
- On April 3, the CFO issued a directive to freeze hiring and limit discretionary spending. Under this directive, departments were ordered to cancel discretionary contracts and purchases, make every attempt to limit overtime and limit new contracts to only those deemed critical by the CFO
- The Chief Procurement Officer is renegotiating contracts with major vendors to achieve savings
- The City has requested and received cost savings from authorities to reduce appropriations
- The City is maximizing federal reimbursement for additional spending on COVID-19
- The City has instituted a number of workforce changes to reduce spending, preserve core City services, and treat employees fairly
