- 7 CHAIRPERSON BELL: Ms. White, would you
- 8 introduce the Board staff, please.
- 9 SECRETARY WHITE: Yes, sir, thank you,
- 10 Chairperson Bell.
- 11 CHAIRPERSON BELL: And yourself.
- 12 SECRETARY WHITE: Yes. I am Melanie
- 13 White, Interim Secretary to the Board, and also
- 14 present during the meeting today before I move to
- 15 the staff introductions, the Department of
- 16 Innovation and Technology is monitoring the Board's
- 17 meeting today, and our court reporter is
- 18 Ms. Theresa Roberts. And the following Board staff

- 16 CHAIRPERSON BELL: I'm jumping ahead of
- 17 myself. The reading glasses are not working for me.
- 18 The Chair would entertain a motion for approval of
- 19 the agenda for August 13.
- 20 COMMISSIONER BURCH: So moved.
- 21 COMMISSIONER HOLLEY: Supported.
- 22 CHAIRPERSON BELL: It's been properly
- 23 moved and supported. Those in favor, yes.
- 24 COMMISSIONER HOLT: Yes.
- 25 COMMISSIONER DAVIS: Yes.



- 1 CHAIRPERSON BELL: Thank you. Next item
- is approval of minutes from August 6, 2020. 2.
- 3 in favor, yes.
- 4 COMMISSIONER HOLT: Yes.
- 5 COMMISSIONER HERNANDEZ:
- 6 COMMISSIONER DAVIS: Yes.
- 7 CHAIRPERSON BELL: Any necessary
- corrections or addition to the minutes? Thank you. 8
- 9 Good afternoon again, I want to welcome
- you to the weekly meeting of the Detroit Board of 10
- Police Commissioners. As it's been stated, I am 11
- 12 Willie Bell, Chair of the Board of Police
- 13 Commission. I am from District 4, the East side of
- 14 Detroit.
- 15 Our theme is Accountability Through
- 16 Civilian Oversight since 1974. Civilian oversight
- is the form of civil rights protection. Oversight 17
- (inaudible) are at the forefront investigating, 18
- reviewing and auditing individual cases of pattern 19
- of misconduct, bias policing, illegal searches, 20
- excessive force, unlawful arrest, use of deadly 21
- 2.2 force and other issues that impact policing. That
- 23 is under Article 7 of the City Charter 803, the
- duties of the Board of Police Commissioner. 2.4
- 25 Number 3, receive and resolved as



- 1 provided in this Chapter any complaint concerning
- 2 the operations of the police department and forward
- 3 all allegations of criminality to the appropriate
- 4 internal-external law enforcement agency. In most
- 5 cases that would be handled by Internal Affairs of
- 6 the Detroit Police Department.
- 7 Noncriminal complaints are handled by
- 8 Office of the Chief Investigator, Office of the
- 9 Board of Police Commission. In today's Detroit Free
- 10 Press, polls show confidence in police at new low.
- 11 Surveys spotlight growing racial divide, balance
- 12 polls have indicated the American confidence in
- 13 police fell to the lowest reported in nearly 30
- 14 years. Only 80 percent of Americans say they have a
- 15 great deal or quite a lot of confidence in policing,
- 16 down from 53 percent the previous year. This month,
- 17 we the BOPC, the Board of Police Commissioners, are
- 18 rolling out our own survey to you, our community.
- 19 We are seeking your feedback on policing in Detroit.
- 20 We hope to undertake that this month.
- Commissioners, you have a copy of the
- 22 survey and you still have opportunity to weigh on it
- 23 before we share it with the public. So take a look
- 24 at it and contact Mr. White if you have any concern.
- Now, I'm going to move on to Commissioner



- 1 Burch, District 3, to come before you with her
- 2 report on the good and well being of the Board of
- 3 Police Commissioners, City of Detroit, from her
- 4 viewpoint. Commissioner.
- 5 COMMISSIONER BURCH: Thank you, Chair
- 6 Bell, and to the honorable colleagues that are on
- 7 the Board and to Chief Craig and to the DPD entire
- 8 staff. I just want to briefly share that my
- 9 experience with the Board of Police Commissioners
- 10 has been very interesting, very exciting, as I was
- 11 led by the mentors that are no longer there, that
- 12 would be Commissioner Dewaelsche, Brooks and also
- 13 Ms. Lisa is still there, but she's just been absent.
- 14 But these ladies led me into all of the world I
- 15 never knew. So it's almost -- I want everybody to
- 16 know that as a commissioner of Third District, we're
- 17 learning together. I don't believe the Third
- 18 District experienced the commissioners before, so
- 19 it's a wonderful thing that we're learning together.
- 20 I wanted to share like Reverend Holley
- 21 did that my whole history comes from Alabama where
- 22 my family came up here. So enjoining all the things
- 23 that I've been allowed to do, I read the book called
- 24 Purpose Driven Life, that's by Rick Warren. So that
- 25 shared with me that the purpose in life, we don't



- 1 know where we're going, but as I've gotten to my
- 2 age, I am so impressed by the people that I've met,
- 3 that the chivalry of the Board of Police
- 4 Commissioners in the past, it was Gregory Hicks. I
- 5 thank Mr. Brown, I thank Mr. Wyrick, the attorney, I
- 6 thank Ms. Blossom, I thank Ms. Yolanda, I thank
- 7 Melanie. There's so many people, if I left your
- 8 name out, it's been an experience, a roller coaster
- 9 that when we visit some of the new people that are
- 10 on the Board now, we had the opportunity to visit
- 11 southwest Detroit. And when I saw the DC Bettison
- 12 there and all the people knew him, I said, how do
- 13 you know Bettison when he's way on the east side.
- 14 So for that gentleman to cover so much parts of the
- 15 whole city as the neighborhood liaison, I commend
- 16 him for that. But again in all of the remembering
- 17 that I have of this Board, I love the graduations.
- 18 I was sad that the home going of so many officers in
- 19 the beginning of 2019 -- I mean '18, and so I've
- 20 experienced so much. And all of the new
- 21 commissioners, you missed all those beautiful
- 22 luncheon or dinners that we would have when we would
- 23 go out to the community meetings, they were simply
- awesome.
- 25 And then I just want to say that I'm

- 2 between elected or appointed or at-large
- 3 commissioners. I'm learning all that. So, again,
- 4 it's about communicating, it's about your purpose.
- 5 I thank you for the opportunity to speak, but one
- 6 thing that I always loved to do was take pictures.
- 7 The whole commission would laugh at me when I
- 8 brought out my old fashioned camera and took
- 9 pictures. But they'd be happy when I framed them
- 10 and gave each commissioner a picture. You all
- 11 remember that? So the best picture that we took
- 12 together was with the Honorable, the deceased,
- 13 Honorable Damon Keith. We took a picture together
- 14 upon my initiative, to say, may we take a picture
- 15 together? Mayor Duggan said yes. So we have a

- 4 that's nice, but I'm saying my district doesn't
- 5 realize that, they don't know the purpose yet. And
- 6 I just want us to be on one accord, to help this
- 7 city, help our Detroit Police Department become
- 8 better. So as we work together, Mr. Bell, we'll be
- 9 a better city, and I thank you for the opportunity

- 11 CHAIRPERSON BELL: Thank you,
- 12 Commissioner Burch, for sharing that very
- interesting comments, and I know your heart is dear
- 14 to that community. And thank you for those Polaroid
- 15 pictures. Did you hear me?
- 16 COMMISSIONER BURCH: Yes, I heard you.
- 17 CHAIRPERSON BELL: Because that picture
- 18 with Judge Damon Keith is historic. You know, that
- 19 was one opportunity and you seized the moment, and I
- 20 treasure that picture in terms of prominent displays
- 21 in my household. So I want to thank you.
- 22 COMMISSIONER BURCH: That's wonderful.
- 23 Thank you.
- 24 CHAIRPERSON BELL: Thank you.
- Now, we're going to At-Large duly



- 1 appointed Hernandez. He can properly introduce
- 2 himself At-Large.
- 3 COMMISSIONER HERNANDEZ: Thank you, Chair
- 4 Bell, first of all for the platform and opportunity
- 5 to just share brief thoughts. I certainly echo the
- 6 comments of my fellow Commissioner, Commissioner
- 7 Burch, and in my new tenure I would offer a very
- 8 brief reflection, not only for myself but for my
- 9 colleagues on the Honorable Board. Someone very
- 10 important to me several years ago told me navigating
- 11 through life, whether it be personal or
- 12 professional, leadership is nothing more and nothing
- 13 less than that. And I think it's very appropriate
- 14 for the oversight responsibilities that we have here
- 15 on this board for us to act accordingly and know
- 16 that we do carry a responsibility in our
- 17 communities, independent of which specific district
- 18 we may represent, independent of our appointment or
- 19 election, we all have common ground in trying to
- 20 serve our communities as best as we can collectively
- 21 as a board. And in doing so, I would offer as well,
- 22 that diligence with integrity and action I think is
- 23 key as we look at, you know, the different
- 24 guidelines and policy and impact that we can
- 25 potentially have in our communities, not just for



- 1 this generation, but for the future as well. And
- 2 just something of very simple value that I try and
- 3 keep close to the heart is to listen with kindness.
- 4 I think it goes without saying a lot of times when
- 5 we interact and engage with folks in the community
- 6 who are our neighbors independent again of which
- 7 community we may specifically live in or represent.
- 8 And so it's important to do that. We have an
- 9 opportunity as a board to model oversight board
- 10 across the country. And so I would encourage and
- 11 invite each of you to do so collectively again as a
- 12 team. And in the coming days I'll extend sort of an
- 13 individual offer to each of you for us to connect to
- 14 try and find what that common ground looks like so
- 15 that we can find that common purpose and deliver
- 16 that common purpose for our community.
- 17 So again, thank you, Chair Bell, for the
- 18 opportunity and to each of my colleagues and also to
- 19 DC Bryant and the entire DPD staff, just know that
- 20 our partnership here is present; that I look forward
- 21 to nurturing continuously that partnership. So
- 22 thank you.
- 23 CHAIRPERSON BELL: Thank you,
- 24 Commissioner Hernandez. I think your reflection,
- 25 you know, is accurate in terms of we are here to



- 1 serve and we appreciate that.
- I see Commissioner Burton has joined us.
- 3 We welcome you to the meeting.
- 4 Just before I move on to promotion
- 5 candidates, I want to acknowledge Commissioner
- 6 Vice-Chair Holt for the opportunity to visit the
- 7 recruiting section in terms of getting enlightening
- 8 in terms of how all that process works. And also
- 9 Commissioner Holt and Commissioner Jones for
- 10 visiting the police academy to get an idea and to be
- 11 enlightened and be informed of how that system
- 12 works. So I would hope other commissioners take
- 13 advantage of getting to know the inner workings of
- 14 it. Those are two very important areas and I can't
- 15 say enough that I want the public to know that we
- 16 are aggressively recruiting. I want to pick that
- 17 mantel up that we have probably dropped the ball in
- 18 the last couple of weeks with Commissioners Brooks
- 19 and Dewaelsche not being with us, but we are
- 20 actively recruiting to make sure we sort of share
- 21 that initially with Ms. White's remarks about
- 22 recruiting; that we are recruiting.
- 23 CHAIRPERSON BELL: Now, if we move on
- 24 to --
- 25 COMMISSIONER HOLT: Through the chair.



- 1 CHAIRPERSON BELL: Yes, ma'am.
- 2. COMMISSIONER HOLT: One little comment,
- 3 when I was at the recruiting area, Sergeant Gonzales
- kept referring to me as Commissioner Brooks. 4
- ultimately Lieutenant Combs said, well, really this 5
- is Commissioner Holt. And, of course, Sergeant 6
- 7 Gonzales apologized, but I was favored by the
- comment, so I didn't say anything. But yeah, she is 8
- very well known in the community for her recruitment 9
- of possible police officers. 10
- 11 CHAIRPERSON BELL: Thank you, thank you,
- 12 I appreciate that.
- 13 We're going to move on to the 2020
- detective promotion candidates. Commissioners, you 14
- 15 have received the list of officers that's being
- 16 promoted to detective with all the background
- 17 information, all the details and I assume if you had
- any concern, you contacted Mrs. White. She sent it 18
- 19 out very timely and you got a hard copy of it. So
- the Chair would entertain a motion from the body, if 20
- 21 that's appropriate.
- 2.2 COMMISSIONER HOLT: Through the Chair, I
- 23 move that the Board approve the promotions for the
- 2.4 following members to the rank of detective and those
- members are as follows: Commissioner Jones. 25



- 1 COMMISSIONER JONES: Okay, all right.
- 2 First up we have -- and thank you also through the
- 3 Chair and also to the Vice-Chair, Commissioner Holt.
- 4 First we have Corporal Jessica A. Johns, Police
- 5 Officer, Nicole L. Draper, Police Officer Marcus
- 6 Rice, Police Officer Shawn A. Humperdale, Police
- 7 Officer, Tara R. Lawson, Police Officer Mark L.
- 8 Thompson, Police Officer, Listene A. Gilbert, Police
- 9 Officer Martha G. Wilaham, Police Office Michael B.
- 10 Prestige, and Police Officer Anthony N. Bayso.
- 11 COMMISSIONER HOLT: Thank you.
- 12 CHAIRPERSON BELL: Could we just pause,
- 13 Commissioner Holt, for one second. Did I hear a
- 14 second on that?
- 15 COMMISSIONER HOLLEY: I did.
- 16 CHAIRPERSON BELL: Okay. Commissioner
- 17 Holley seconded it. Now Vice-Chair Holt.
- 18 SECRETARY WHITE: Oh, excuse me.
- 19 CHAIRPERSON BELL: Go ahead.
- 20 SECRETARY WHITE: There are about --
- 21 there are several more candidates.
- 22 CHAIRPERSON BELL: Yes, we haven't
- 23 finished the list yet. We just went through the
- 24 first ten.
- 25 COMMISSIONER HOLT: Okay. Police Officer



- 1 Edward Chesser, Police Officer Ashley L. Burgholtz,
- 2 Police Officer Vincent C. Spikes, Police Officer
- 3 Renald L. Atard, Police Officer Tamera Randolph,
- 4 Police Officer Steven L. Pierce, Police Officer
- 5 Kelly D. James Police Officer Lee P. Dire, Police
- 6 Officer Catherine L. Golyum, Police Officer
- 7 Christian C. Wynans-Jordan.
- 8 CHAIRPERSON BELL: Ms. White, did we fill
- 9 all the names?
- 10 SECRETARY WHITE: Yes, sir.
- 11 CHAIRPERSON BELL: Thank you. It's been
- 12 properly moved and seconded. Any discussion?
- Those in favor, yes.
- 14 COMMISSIONER HOLT: Yes.
- 15 COMMISSIONER BURCH: Yes.
- 16 COMMISSIONER HERNANDEZ: Yes.
- 17 CHAIRPERSON BELL: Do we need a roll call
- 18 or are we satisfied with the yeses?
- Those in opposition, no.
- 20 COMMISSIONER DAVIS: No.
- 21 COMMISSIONER BURTON: No.
- 22 CHAIRPERSON BELL: Ms. White.
- 23 SECRETARY WHITE: Motion passed.
- 24 CHAIRPERSON BELL: Thank you. I want to
- 25 congratulate all those who have been promoted to the



- 1 rank of detective. Normally, they would be in
- 2 attendance if we were meeting in person, so I want
- 3 to wish them the best, and we're looking forward to
- 4 interaction with them in terms of how they
- 5 (inaudible) also with their promotion (inaudible).
- 6 The next Item would be Deputy Chief
- 7 Bryant on behalf of Chief Craig.
- 8 DEPUTY CHIEF BRYANT: Yes, through the
- 9 Chair. First I'd like to talk about a couple of
- 10 officers that are injured and give you some updates
- 11 on that. We have Officer Eugene Fielder assigned to
- 12 the Tenth Precinct. This was the officer that was
- injured during the protests and had the cone that
- 14 struck his neck. He is currently off disabled and
- 15 recovering at home right now from his injuries.
- We also have two police officers from the
- 17 Fourth Precinct, Police Officer Estebon Porotti, and
- 18 Police Officer Keith Anthony, they were assisting
- 19 with an arrest regarding a kidnapping suspect, and
- 20 they were both injured. They received injuries to
- 21 their head and some bite injuries as well. They are
- 22 both currently at home recovering from their
- 23 injuries as well.
- As it relates to crime, we are currently
- 25 up seven percent in violent crimes and around 12



- 1 percent in our property crimes. Over the course of
- 2 the week, we've had 171 felony arrests, we issued
- 3 1,671 citations and ordinances. We confiscated 127
- 4 handguns, 26 long guns and had 109 DCW arrests for
- 5 the week.
- 6 As it relates to our drag racing detail
- 7 for the weekend, our stats are as follows: 194
- 8 traffic stops, 223 tickets, 33 tows, 12 felony
- 9 arrests, six weapons recovered. So that is our
- 10 stats in regards to the enforcement that we've been
- 11 doing for the week.
- 12 I want to address -- I know that there
- 13 was an issue or concern for the address of 9000
- 14 Woodward, the Little Rock Baptist Church. Our
- 15 officers had been doing enforcement at that location
- 16 over the weekend. They checked the location, there
- 17 was no activity found. They will continue to check
- 18 that location going forward, so that's going to be
- 19 something that we keep on our radar to make sure
- 20 that we don't have any issues or concerns in that
- 21 area.
- 22 CHAIRPERSON BELL: Thank you.
- DEPUTY CHIEF BRYANT: No problem, sir.
- 24 And as it relates to some of the questions in
- 25 regards -- oh, our COVID numbers. We have 20



- 1 members that are currently positive with COVID at
- 2 this time and 30 that are quarantined. So that's 20
- 3 positive and 30 quarantined.
- As it relates to our protests, they've
- 5 been in southwest for the past three days. They
- 6 will be going back downtown, the information that we
- 7 have, starting tomorrow. One of the issues or
- 8 concerns that we had in regards to them being
- 9 downtown is, I don't know if you guys are aware, but
- 10 they had a late start date, a late start time, so
- 11 they started around 7 P.M. last Friday and they
- 12 actually, after their protests, they marched through
- 13 Greektown. And as you know on the weekend, downtown
- 14 traffic is extremely heavy. So that is a concern to
- 15 us in regards to not only their safety, but the
- 16 safety of, you know, the patrons for downtown, as
- 17 well as the officers. So we'll continue to monitor
- 18 that and try to make sure that we keep everyone safe
- 19 in regards to that. But we know that they'll be
- 20 downtown again this week.
- 21 As it relates to issues regarding
- 22 internal affairs investigations, specifically
- 23 Officer Bill Hood's employment, I'm going to let
- 24 Director Graveline speak to that issue. For
- 25 questions regarding our Green Light, the startup



- 1 costs and everything, we have Captain Coster that
- 2 will address that as well.
- 3 CHAIRPERSON BELL: Thank you.
- 4 DEPUTY CHIEF BRYANT: Director, we can't
- 5 hear you.
- 6 SECRETARY WHITE: The microphone is
- 7 unmuted at this time for Director Graveline.
- 8 MR. TOSQUIARIC: Do you want me to jump
- 9 in while he's figuring that out?
- 10 CHAIRPERSON BELL: Yes, sir, that will
- 11 work, sir.
- 12 MR. TOSQUIARIC: Thank you, through the
- 13 Chair, Mr. Davis had a question last week and I was
- unable to answer it at the time, but there's average
- 15 costs, most popular option is to do a lease.
- 16 Comcast is the most popular vendor. The lease is
- 17 approximately a \$1,000 down and \$150 a month which
- 18 excludes the internet. Right now, as I mentioned
- 19 last week Comcast has a 50 percent off installation
- 20 and multi-site discount. There are pay-up-front
- 21 options that average between 5 and 6,000 depending
- 22 on which vendor they select, and that includes
- 23 camera and cloud storage. And if you or anybody is
- interested, then go to the city's website and go to
- 25 the Project Green Line Detroit site. There is a



- 1 button right on the main page there that has all the
- 2 costs and how to get involved and it will show
- 3 Option One, lease and cameras, between Comcast and
- 4 Kronus and Guardian Alarm and Infinite Technologies,
- 5 option on purchase with the different installers on
- 6 there: Access Surveillance, Clearview, Security
- 7 Pro, Guardian Alarm, ITG Systems, IC Data
- 8 Communications, Infinite Technologies, I-View, James
- 9 the Electrical Contractor, Logical Owl, Logitech
- 10 Incorporated, Prudential. Then there's pricing for
- 11 signage. There's the two vendors and the pricing
- 12 goes between 450 to 650 for signage. And then the
- 13 two vendors for the Green Light itself, and the
- 14 pricing for that is between 450 and 500.
- 15 CHAIRPERSON BELL: Thank you, sir.
- 16 Ms. White.
- 17 SECRETARY WHITE: Yes, Director
- 18 Graveline.
- 19 COMMISSIONER HERNANDEZ: I see his lips
- 20 moving.
- 21 SECRETARY WHITE: Okay. On this end the
- 22 microphone is unmuted, so there obviously are some
- 23 technical difficulties.
- 24 DEPUTY CHIEF BRYANT: Through the chair.
- 25 CHAIRPERSON BELL: Yes, ma'am.



- 1 DEPUTY CHIEF BRYANT: So there was a
- 2 question in regards to the Major Violators Unit as
- 3 well I'd like to address if that's okay.
- 4 CHAIRPERSON BELL: Yes, ma'am. Thank
- 5 you.
- 6 DEPUTY CHIEF BRYANT: Right now we have,
- 7 the Major Violators Unit is still up and running.
- 8 We have Commander Pritchard who's the commander over
- 9 Major Violators. She's actually Commander of
- 10 Organized Crime, Major Violators falls under
- 11 Organized Crime. We have Captain Ryan Connor who's
- 12 the captain at Organized Crime and then Deputy Chief
- 13 Wilson, who is the Deputy Chief of the Detective
- 14 Bureau, and Organized Crime falls under him as well.
- 15 So I just wanted to put that on the record. That's
- 16 the leadership at this time.
- 17 CHAIRPERSON BELL: Thank you. So we
- 18 might not have the Director report at this time?
- 19 SECRETARY WHITE: Not at this specific
- 20 time.
- 21 DIRECTOR GRAVELINE: I believe I can talk
- 22 now. I'm on my phone now as opposed to the
- 23 computer. I apologize for that.
- 24 CHAIRPERSON BELL: No problem. Thank
- 25 you.



- 1 DIRECTOR GRAVELINE: Through the chair.
- 2. Last week Commissioner Brown had some questions
- concerning the investigation into Mr. Chancellor and 3
- specifically how that impacted Sergeant Gilhood. 4
- This particular investigation came to our attention 5
- 6 in a slightly different manner than most. The Wayne
- County Prosecutor's Convention Integrity Unit 7
- brought it to our attention approximately -- or at 8
- least their conclusions in March of this year. 9
- they came and let us know about their investigation 10
- and its conclusions. As soon as we found out, we 11
- 12 opened our own internal affairs investigation.
- 13 that investigation was opened up on March 20th of
- 14 this year. Some of the details of the investigation
- 15 are a little complex in terms of the corroborating
- 16 information. And so our investigator has been very
- active over the last several months interviewing 17
- several members of the command as well as through 18
- 19 last week. He was running down certain leads on
- 20 some of the corroborating information.
- 21 coming close to finalizing that report.
- believes the investigators, Sergeant Wilson in our 2.2
- 23 Internal Affairs, she believes that that report
- 2.4 should be complete next week for the chain of
- command. And it will be at that time that we will 25



- 1 bring the chief our recommendations as to the duty
- 2 status of Sergeant Gilhood. So that's where we're
- 3 at with that particular investigation.
- 4 Generally speaking, I think to speak to
- 5 your question, Commissioner Brown, is what's his
- 6 duty status right now? Right now he remains full
- 7 duty. He's not in an investigative capacity. He's
- 8 currently working as a sergeant in the 8th Precinct
- 9 on one of the platoons there. But in terms of once
- 10 we have our investigation done, we'll be able to
- 11 better advise Chief as to what his duty status
- 12 should be.
- 13 CHAIRPERSON BELL: Thank you, Director
- 14 Graveline. Do you have any questions for the Deputy
- 15 Chief in reference to the report?
- 16 COMMISSIONER HOLLEY: Through the Chair,
- 17 CHAIRPERSON BELL: Commissioner Holley,
- 18 Commissioner Davis.
- 19 COMMISSIONER BURCH: Mr. Chair.
- 20 CHAIRPERSON BELL: Commissioner Holley,
- 21 Commissioner Davis, then Commissioner Burch.
- 22 COMMISSIONER HOLLEY: To the chief,
- 23 assistant chiefs, is it assistant chief, is that who
- 24 I'm talking to?
- 25 CHAIRPERSON BELL: Deputy Chief.



- 1 COMMISSIONER HOLLEY: Deputy Chief.
- 2 Okay. I'm sorry. What are the protesters' demands
- 3 and then who's basically meeting with them about the
- 4 demands?
- 5 DEPUTY CHIEF BRYANT: Through the chair,
- 6 their demands are fire Chief Craig and the Mayor and
- 7 defund the police, that's their demands.
- 8 COMMISSIONER HOLLEY: So that means
- 9 they're going to be there for a long time.
- 10 DEPUTY CHIEF BRYANT: Yes, sir.
- 11 CHAIRPERSON BELL: Thank you,
- 12 Commissioner Holley. Commissioner Davis.
- 13 COMMISSIONER DAVIS: Yes, a couple
- 14 things. One, I know quite some time ago there was a
- 15 news article in the paper and we was told there was
- 16 an investigation. Was there any update on the
- 17 person that was signing the Chief's signature?
- 18 Because I know it appears like there's a number of
- 19 investigations that are started, but we never get no
- 20 update on it. Also, I would like an update on --
- 21 because I've been requesting for quite some time
- 22 about deployment, you know, deployment mobilization
- and when will we have that information?
- 24 DEPUTY CHIEF BRYANT: Through the Chair,
- 25 I would direct your question in regards to an



- 1 investigation to Director Graveline, as he's in
- 2 charge of Professional Standards. But when you say,
- 3 a request on mobilization, could you be more
- 4 specific? I'm not really understanding.
- 5 COMMISSIONER DAVIS: Well, quite some
- 6 time ago, I think almost a year ago, I asked about a
- 7 mobilization plan and how long does it take officers
- 8 to report if an emergency happens because it appears
- 9 like some information should be more forthcoming
- 10 than it has been.
- 11 DEPUTY CHIEF BRYANT: Well, through the
- 12 chair, I will definitely bring that concern back,
- 13 but we actually have our officers respond extremely
- 14 fast. We've been dealing with these protests and I
- 15 can tell you that we have manpower around the clock.
- 16 COMMISSIONER DAVIS: Does it show how
- 17 long it takes them from their home to get to the
- 18 city if there's an emergency to their work location?
- 19 CHAIRPERSON BELL: They are working on
- 20 that plan. We received information, they hope to
- 21 complete that process that you requested. So
- 22 hopefully we will get notification that's been
- 23 completed.
- 24 DIRECTOR GRAVELINE: Through the chair.
- 25 to Commissioner Davis's question about the



- 1 investigation into the signature, that investigation
- 2 ended up being inconclusive. Several people who
- 3 worked in the capacity that might have signed it are
- 4 no longer with the department and we're not able to
- 5 interview them. And so we were not able to
- 6 definitively identify who signed Chief's signature,
- 7 although we have some strong suspicions as to who
- 8 that person is. The person that we believe it is is
- 9 no longer with the department. We were no longer
- 10 able to interview that person. So in terms of the
- 11 findings of the investigation, that would be
- 12 inconclusive.
- 13 COMMISSIONER DAVIS: That would be
- 14 helpful to have that information sometimes.
- 15 DIRECTOR GRAVELINE: Yes, sir.
- 16 CHAIRPERSON BELL: Thank you.
- 17 Commissioner Burch.
- 18 COMMISSIONER BURCH: Yes, thank you, Mr.
- 19 Chair. To DC Bryant, good afternoon, and DC Bryant
- 20 is part of the East side as far as taking care of
- 21 the Commander Phrafee and also the commander in
- 22 Number 9. I just wanted to ask you -- these are
- 23 follow ups like Commissioner Davis, about, first of
- 24 all, the ordinances regarding the pool and the car
- 25 parked up in the yard, we had a meeting on this past



- 1 Tuesday, a Community Relations meeting, where all of
- 2 the citizens agreed, but now we have proof,
- 3 ordinance numbers that we can give to you later, but
- 4 we just want the officers to take care of what we,
- 5 as citizens bring to you and like Commissioner Brown
- 6 asked, and it was a follow up that I don't get
- 7 answers back far as the young man and officer --
- 8 Mr. Bell, what happened is the officer did a donut
- 9 in Greektown, but he was caught on tape. So however
- 10 the police go and pick up that young man, what
- 11 happened to the officer? How was he reprimanded for
- 12 doing that? So those are two first, and then I have
- one follow up, Mr. Bell.
- 14 CHAIRPERSON BELL: Yes, ma'am.
- DEPUTY CHIEF BRYANT: Through the Chair.
- 16 CHAIRPERSON BELL: Yes, ma'am.
- 17 DEPUTY CHIEF BRYANT: We've had several
- 18 officers in regards to the specific complaint about
- 19 the house a couple doors down from you, Commissioner
- 20 Burch, that had responded to that. Now, you just
- 21 sent me today a picture of the vehicle, so I'll
- 22 address those officers that go back out there and
- 23 deal with it now as we speak so that they can go
- 24 ahead and handle that.
- In regards to the kiddie pool, what we're



- 1 going to do, like I explained to you yesterday on
- 2 the phone, is have a conversation with the young
- 3 homeowner because we're going to ask them, would
- 4 they please be willing to put that pool in the back.
- 5 Unfortunately, having the kiddie pool out is not a
- 6 violation. So we're going to have that conversation
- 7 with them because, you know, we think that maybe
- 8 through community relations and through having that
- 9 conversation they'd be willing to move it.
- 10 COMMISSIONER BURCH: Okay. Could I
- 11 respond, Mr. Bell?
- 12 CHAIRPERSON BELL: Yes, ma'am.
- 13 COMMISSIONER BURCH: Because I do think
- 14 that we do have the ordinance that says that is
- 15 against the law. So when I shared these ordinances
- 16 you can read them for yourself, that is was updated
- 17 even to the July 19, 2019, that you cannot put a
- 18 pool, regardless if it's a wading pool, on the front
- 19 without it being fenced in because that's an
- 20 endangerment to that child. So I can share that all
- 21 with you off the air if the Board wants to follow up
- 22 That's all.
- DEPUTY CHIEF BRYANT: Through the chair,
- 24 I did consult with Deputy Chief Ha in regards to
- 25 that because we want to make sure that we, you know,



- 1 follow the law and make sure that we're not
- 2 violating anybody's rights as well. So we will have
- 3 that conversation offline, but according to Deputy
- 4 Chief Ha, you know, it's not a violation.
- 5 COMMISSIONER BURCH: Okay. So he can
- 6 share off the line. The other issue is that we
- 7 think that our whole area from Six Mile to Eight
- 8 Mile, whether it be Dequindre or Conant or Ryan
- 9 Road, that I-75 is under repair, right, under
- 10 construction. So, therefore, that leaves that
- 11 traffic to come up, and usually they use Dequindre
- 12 because they can't use I-75. And DC Bryant, we've
- 13 been saying that these motorists speed at 75 to 100.
- 14 I mean, they get on your back when regular people
- 15 are driving down the street, they get on your back.
- 16 As a matter of fact, they'll jump to the other side
- 17 to get away from you. So that's why we think this
- 18 area needs special attention.
- 19 DEPUTY CHIEF BRYANT: Through the chair,
- 20 yes, ma'am, and to your point, traffic enforcement
- 21 has been given that location as special attention.
- 22 In a week's time we wrote 1,671 citations. So we
- 23 are absolutely trying to address the concerns in
- 24 regards to traffic.
- 25 COMMISSIONER BURCH: Thank you.



- 1 COMMISSIONER BROWN: Through the Chair.
- 2. CHAIRPERSON BELL: Yes.
- 3 COMMISSIONER BROWN: DC Bryant, I just
- want to thank all of the men and women of the 4
- 5 department for the work, the hard work they're doing
- in the last few weeks with the drag racing and all 6
- 7 the things. I know we're stretched pretty good for
- removing the guns off the streets, and more 8
- 9 especially I want to thank our NPOs out there.
- There's nothing that I haven't called to have 10
- resolved that they haven't checked into it, whether 11
- 12 it's an abandoned vehicle or blight in the yard,
- 13 anything like that. I think they're doing a
- 14 wonderful job.
- 15 I just had one question and maybe I need
- 16 to just make a phone call. And Chairman Bell, you
- 17 can probably chime in on this as well if you have
- information. But with regard to all the parking 18
- 19 issues that we're seeing, where is the parking
- authority? Because I'm looking at and a lot of 20
- things that we're doing that we have to be careful 21
- and not make things a police matter. And we have a 2.2
- unit out there, that's the parking authority. Why 23
- aren't they out there writing tickets, and different 2.4
- 25 things like that, building issues and stuff like



- 1 that? Where are the BC officers and people who work
- 2 for there? Do we need to be making those calls
- 3 ourselves to try to, you know, free up our officers
- 4 for these things that are not police issues? I
- 5 mean, I know we write tickets from time to time for
- 6 speeders for parking and different things like that
- 7 and blight; where is BC, where's the parking
- 8 authority? Is that something we can help out our
- 9 department and help you out to lighten your load a
- 10 little bit to get some help out there for our
- 11 officers to free up some of the time that they have
- 12 regarding some of these issues?
- 13 DEPUTY CHIEF BRYANT: Through the Chair,
- 14 we do have really good relationships with our
- 15 partners in regards to these situations. So the
- 16 commanders and captains have relationships with DC,
- 17 they have relationships with parking enforcement.
- 18 So we do work hand in hand with them. It's been
- 19 unfortunate because of the things that we've been
- 20 going through over the past few month, things have
- 21 stalled out a little bit, so we are hoping to be
- 22 able to pick up and do more together, with more
- 23 collaboration to be able to address a lot of these
- 24 quality of life issues.
- 25 COMMISSIONER BROWN: Thank you, thank you



- 1 all for your service, those that are listening.
- 2 CHAIRPERSON BELL: Thank you. Any other
- 3 questions for the Deputy Chief? Commissioner
- 4 Burton.
- 5 SECRETARY WHITE: He's on mute. He needs
- 6 to unmute himself, please. There you go.
- 7 COMMISSIONER BURTON: A few weeks ago --
- 8 you guys had me muted. But a few weeks ago I called
- 9 for a question for the Assistant Deputy Chief. I
- 10 called for the video of the protestor that was ran
- 11 over by DPD. I wanted to see the video two hours
- 12 before the incident occurred and an hour after. Do
- 13 you know when that video will be available for the
- 14 commission?
- In addition, I speak on the behalf of the
- 16 residents in the 5th District, I'd like to know what
- is the police response times for priority 1, 2,
- 18 priority 3 and priority 4 calls here in the city of
- 19 Detroit? Not just Green Light locations, but
- 20 priority 1, 2, 3 and 4?
- 21 DEPUTY CHIEF BRYANT: Through the chair,
- 22 Director Graveline would be better equipped to
- 23 answer the question in regards to the video. But as
- 24 it relates to our Priority 1 calls, we're averaging
- 25 right now, priority 1 calls, we're averaging about,



- 1 is it 14, 14 minutes? So I mean, you know, it's a
- 2 work in progress, but, you know, we have a lot more
- 3 calls for service than we've had. But I can get you
- 4 those specific numbers. I think it's in the report
- 5 that you get. I think you have that report, if I'm
- 6 not mistaken, it breaks down the calls for service
- 7 and it breaks it down by precinct as well.
- 8 COMMISSIONER BURTON: Can you please give
- 9 that to Ms. Melanie White so she can share with the
- 10 rest of the Board, please?
- 11 SECRETARY WHITE: Through the chair, that
- 12 report is included in the weekly packet.
- 13 CHAIRPERSON BELL: Yes, ma'am, thank you.
- 14 SECRETARY WHITE: So it's already
- 15 included in your packet.
- 16 COMMISSIONER BURTON: But it's not a
- 17 breakdown for priority 1, 2, 3, and priority 4
- 18 calls.
- 19 DEPUTY CHIEF BRYANT: It's a breakdown
- 20 for priority 1 and priority 2. It is a breakdown
- 21 and it's in that report that we provided.
- 22 COMMISSIONER BURTON: But the Detroit
- 23 Police Department does have priority 3 and priority
- 24 4 calls as well, right?
- 25 DEPUTY CHIEF BRYANT: So what we break



- 1 down is our priority 1 and priority 2. If you're
- 2 asking for additional information, I will take that
- 3 back to the Chief.
- 4 COMMISSIONER BURTON: Sure.
- 5 CHAIRPERSON BELL: Thank you. Ms. White,
- 6 we'll coordinate that to see if that's appropriate.
- 7 SECRETARY WHITE: Yes, sir.
- 8 CHAIRPERSON BELL: We're concerned about
- 9 one and two. The second question, Director, did you
- 10 hear the question?
- 11 DIRECTOR GRAVELINE: Yes, sir. Through
- 12 the chair, if any of the Commissioners would like to
- 13 see that particular video, we can set up the time
- 14 for the Commissioners to come and view the video, as
- 15 Commissioner Burton asked for two hours beforehand.
- 16 We will get the entire video that we have and show
- 17 it to the Commissioners. We're not prepared to
- 18 release it to the public yet, the full video,
- 19 because we're coordinating with the Wayne County
- 20 Prosecutor's Office in terms of review for
- 21 criminality in that situation. So it won't be
- 22 released to the public, but we can definitely make a
- 23 viewing time for any of the Commissioners.
- 24 CHAIRPERSON BELL: Thank you, sir.
- 25 COMMISSIONER BURCH: Through the chair.



- 1 CHAIRPERSON BELL: Yes, ma'am.
- COMMISSIONER BURCH: 2. Thank you, Director
- 3 Graveline. So how then do we make that happen?
- 4 CHAIRPERSON BELL: You contact the
- director through Mrs. White, contact through 5
- Mrs. White. She'll coordinate that for you. Any 6
- 7 commissioners, contact Ms. White. She will
- coordinate that for you. 8
- 9 COMMISSIONER BURCH: Thank you.
- 10 CHAIRPERSON BELL: We're going to move on
- 11 to the HR report.
- 12 I just want to in advance thank
- 13 Lieutenant Coles for filling in those very
- 14 significant shoes of being Director of Personnel.
- 15 As you know we've been absent without the Director
- 16 of Personnel for the last couple months, and
- basically the work has been continued under the lead 17
- of Lieutenant Coles. Now, we're going to hear from 18
- 19 Lieutenant Coles.
- 20 LIEUTENANT COLES: Good afternoon, Board.
- 21 (Response from the Board)
- 2.2 LIEUTENANT COLES: Thank you very much.
- 23 And I do also want to thank Vice-Chair Annie Holt
- for coming down and sitting with us and having the 2.4
- opportunity to address us with the concerns that she 25



- 1 had and some of the questions that she had from the
- 2 Board. We are definitely, again, as we've stated
- 3 before, we're available for anyone to come down and
- 4 have questions or if you want to call us Zoom.
- 5 However you want to get in contact with us, we are
- 6 here. I had all of my supervisors that were
- 7 available sit down and so we can speak and had a
- 8 very open and frank dialogue about people coming
- 9 from the city, people who come from the suburbs or
- 10 anything else that she had a question with. We were
- 11 trying to address all those issues. We have
- 12 absolutely nothing to hide. And I'm extraordinarily
- 13 happy that we have the relationship that you all can
- 14 come down and just kind of, you know, talk to us and
- 15 interact with us any time it's available.
- 16 DEPUTY CHIEF BRYANT: Thank you,
- 17 Lieutenant Coles.
- 18 LIEUTENANT COLES: Yes, ma'am.
- 19 So our human resources bureau report for
- 20 August of 2020, this monthly report is provided as a
- 21 summary of our activities for the month of July
- 22 2020. Also provided are documents which contain
- 23 more detailed information with respect to staffing,
- 24 hiring and manpower by race and sex specifically for
- 25 sworn members.



- 1 For our employment, the current
- 2 department staffing numbers for sworn employees
- 3 positions that we have filled are 2,575. Positions
- 4 that we have vacant are 97, and our total positions
- 5 for sworn are 2,672.
- For our civilian positions, we have 582
- 7 positions filled, we have 161 positions vacant and
- 8 we have 743 total positions.
- 9 As it relates to our sworn recruiting,
- 10 for January, the total applicants that we've had was
- 11 438 for the month, ones that we have in process were
- 12 five. The number that we had hired who started
- 13 their application in July was zero. The lack of
- interest that we had for that month was four,
- 15 temporarily disqualified 180, permanently
- 16 disqualified were 42 and the number that we have
- 17 still awaiting in post testing is 207.
- 18 When we talk about our testing, for the
- 19 month of July, the testing that we have for written,
- we have 91 scheduled, 62 actually appeared, 49
- 21 passed, 13 failed, 2 rescheduled, and we had 27 who
- 22 were no-shows.
- 23 As it goes to the physical agility
- testing, we had 120 scheduled, 81 appeared, 41 of
- 25 those passed, 40 failed, 9 rescheduled and there was



- 1 30 no-shows. We did not have a graduating class in
- 2 the month of July. The total new hires that we
- 3 actually did have in July, we put a class in of 32
- 4 sworn members. So our total new hires for July 2020
- 5 was 32. Our Detroit residency information, for
- 6 sworn members we had the ones who reside in Detroit
- 7 are 577 sworn, and we had 338 civilians and 31
- 8 police assistants.
- 9 Our attrition numbers for July, sworn
- 10 members, we had 22 civilians, 11 police assistants,
- one, for a total attrition for the month of 34.
- 12 Our leave of absence and restricted duty
- 13 was sworn FMLA continuous was 22, FMLA intermittent
- 14 was 110. On medical leave, there were three,
- 15 military leave was three, restricted was 130,
- 16 disabled is 61 and sick 12.
- For our sworn personnel suspensions, we
- 18 had 12 police officers and zero detectives and zero
- 19 lieutenants for a total of 12 who are on suspension.
- 20 Our monthly separation was 22. In our
- 21 drop program, we have a total of 547 members.
- That would conclude my report and I'll
- 23 entertain any questions.
- 24 CHAIRPERSON BELL: Commissioners? Well,
- 25 thank you, Lieutenant Coles.



- 1 COMMISSIONER HOLT: Thank you, Lieutenant
- 2. Coles.
- 3 CHAIRPERSON BELL: Appreciate your work.
- 4 And I just want to also acknowledge AC Stair, who's
- 5 been very, very important as you well know,
- 6 coordinating that position. So we appreciate you,
- 7 LIEUTENANT COLES: Thank you, sir.
- 8 COMMISSIONER BURCH: Mr. Chair.
- 9 CHAIRPERSON BELL: Yes, ma'am.
- COMMISSIONER BURCH: Yes, sir, I just 10
- wanted to say Lieutenant Coles, is this Lieutenant 11
- 12 Brandon Coles?
- 13 LIEUTENANT COLES: No, ma'am. This is
- 14 Lieutenant James Coles with an S.
- 15 COMMISSIONER BURCH: Okay, I'm sorry. I
- 16 thought it was -- that's okay. Well, thank you so
- much. Excellent what you're doing. 17
- 18 LIEUTENANT COLES: Thank you, thank you.
- 19 ma'am.
- 20 CHAIRPERSON BELL: Now, the next item
- would be the 5th Precinct, Commander Ewing, and 21
- Captain Williams, Agent Bernoe that's on the east 22
- 23 side of Detroit. I lived in the 5th precinct for
- quite some time, and I just wanted to acknowledge 24
- Commander Ewing for his years of service to the 5th 25



- 1 Precinct, also years of service to the community and
- 2 the City of Detroit and Detroit Police Department.
- 3 It's outstanding. I'm a little biased because I
- 4 knew Ewing. So Commander Ewing, your presentation,
- 5 Commander.
- 6 COMMANDER EWING: Good afternoon, Board.
- 7 (Response from the Board)
- 8 COMMANDER EWING: Through the chair. I
- 9 have a distinct privilege to be Commander of a
- 10 pretty bright precinct with a lot of engaged
- 11 citizens within the 5th Precinct. We have a couple
- 12 very enterprising community groups, Easton Village,
- 13 Cornerstone, Morningside, Jefferson Chalmers and
- 14 River Bend, just to name a few. With that I enjoy
- 15 being a commander of a precinct for some very
- 16 engaged officers, and you all know through this time
- 17 of COVID and through the times of these protests,
- 18 the members of the 5th Precinct, these men and women
- 19 have continued to do great jobs out there since this
- 20 time.
- 21 So without further delay we're going to
- 22 get into some I think, some great reporting. We'll
- 23 talk about the stats and for that, I'm going to have
- 24 my partner, Captain Keith Williams, chime in.
- 25 CAPTAIN WILLIAMS: Good afternoon,



- 1 everybody. So just looking at crime, I'm going to
- 2 break down this draft for you. Just looking at
- 3 crime in the 5th precinct, we started the year out
- 4 with a 40 percent reduction in homicides in the
- 5 first quarter. I think the second quarter we saw a
- 6 28 percent reduction compared to last year and as of
- 7 today's date, we currently have a 33 percent
- 8 reduction in homicides which equates to the highest
- 9 reduction in the city.
- 10 As far as criminal sexual conduct is
- 11 concerned, our criminal sexual conduct cases saw no
- 12 change as the number is even with last year's
- 13 numbers at 37. It was consistent from last year.
- 14 This year has been almost all of the criminal sexual
- 15 conduct cases are known offenders. So there is no
- 16 stranger-danger patterns of concerns that we have
- 17 noticed.
- 18 As far as aggravated assault, we saw a
- 19 slight increase in aggravated assaults this year
- 20 with an eight percent increase year to date. What
- 21 we noticed is that 43 percent of those aggravated
- 22 assault cases are domestic violence. So our
- 23 strategy has been to team with our Domestic Violence
- 24 Unit on apprehension efforts. We have a very close
- 25 relationship with the commanding officer there. And



- 1 those that are not domestic violence related, we
- 2 relentlessly pursue all known offenders. We also
- 3 continue to work with our victim advocates to ensure
- 4 that the victims are getting services when
- 5 necessary.
- As far as property crimes are concerned,
- 7 here in the 5th Precinct we are down in every
- 8 statistical category. We had a 49 percent reduction
- 9 in burglaries, a 20 percent reduction in larcenies
- 10 and a five percent reduction in motor vehicle theft,
- 11 which gives us a total reduction of 28 percent in
- 12 property crimes in the precinct.
- 13 As far as our nonfatal shootings are
- 14 concerned, we saw no change from last year in the
- 15 first quarter, as the numbers were even. We saw a
- 16 28 percent increase in the second quarter which was
- 17 consistent with the rest of the city. Our strategy
- 18 was to conduct targeted enforcement in those areas
- 19 where our shootings occurred and go after our known
- 20 offenders.
- 21 We've been partnering with our Gang
- 22 Intelligence Units and Cease Fire doing custom
- 23 notifications, so not only to our suspects but to
- 24 our victims. What this has allowed us to do is have
- 25 services offered to not only our victims, whether



- 1 it's housing relocation or other resources so that
- 2 our victims can feel more comfortable providing
- 3 information to us. It also has given us the
- 4 opportunity to speak to the families of the suspects
- 5 to say, hey, we know that your loved ones have been
- 6 getting in trouble, but there are some services that
- 7 you can be offered as well to assist you with
- 8 curving the behavior that your loved one is
- 9 displaying. So we have completed a number of these,
- 10 of visits to both victims and suspects. I think it
- 11 is working. We currently have a 10 percent
- 12 reduction year-to-date in non-fatal shootings. So
- 13 we are again in almost statistical category down in
- 14 crime.
- 15 As far as robberies are concerned,
- 16 year-to-date, we have a 12 percent reduction rate in
- our robberies and a 59 percent reduction within the
- 18 last 28 days.
- 19 As far as some of our strategies, you
- 20 know, we've been concentrating on taking guns off
- 21 the street. Year to date we've taken off 193 guns
- 22 year to date. We've taken 50 guns in the last 28
- 23 days, and that number went up within the last two
- 24 days. We pulled a lot of guns off the street.
- So we're doing targeting enforcement in



- 1 areas. We're relentlessly pursuing our known
- 2 offenders. Those custom notifications that I just
- 3 talked about are working. We continue to partner
- 4 with NBAC to do bed checks with homicide and gang
- 5 intelligence, our major violators and vice
- 6 enforcement and continuing to partner with ATF for
- 7 those known offenders who continue to carry guns.
- 8 Supplement to our strategy is with guns that we send
- 9 our detectives to arraignment to assure that
- 10 appropriate bond-zone offenders are happening.
- 11 We're casting out door hangers on all shootings so
- 12 that witnesses can contact police in private, and we
- 13 are partnering with the 9th Precinct on a
- 14 community-based crime reduction grant. That would
- 15 enable us to convene across that to partnership and
- 16 implement a community-based crime prevention
- 17 strategy in an area surrounding the SCA investment.
- 18 So that's what we have as far as crime is
- 19 concerned. I'm going to have the commander go ahead
- 20 and talk about the community programs that we've
- 21 been doing in the 5th Precinct.
- 22 COMMANDER EWING: Thank you. Through the
- 23 Chair, in the beginning Mr. Bell talked about the
- 24 confidence going down to 48 percent across the
- 25 country with regard to law enforcement. One of the



- 1 strategies that we have in the 5th Precinct, and I
- 2 know the commissioner has attended a police
- 3 community forum in the 5th Precinct before. This
- 4 forum is designed to increase the community
- 5 relations between law enforcement and the citizens.
- 6 It gives both sides an opportunity to talk about the
- 7 harm that's done in terms of police encounters,
- 8 things of that nature. We sit down and have honest
- 9 conversation back and forth how the citizens feel
- 10 about policing, and the officers are able to respond
- 11 from their perspective of why they do certain things
- 12 the way they do them. We have another one coming up
- on August 22nd. That will be, I think, our 13th
- 14 installment of this, but I want to kind of highlight
- 15 what we did on July 18.
- Just recently due to the recent protests,
- 17 COVID, we kind of got together and thought about the
- 18 process, what about our officers, what's in their
- 19 mind's sake. Do they really understand what the
- 20 protest is all about? So we sat down with law
- 21 enforcement officers, both black, white, any other
- 22 nationality who may be at the precinct, and we start
- 23 having candid conversations. And what we ended up
- 24 doing was going back through the whole history of
- 25 the Detroit Police Department. When I say the whole



- 1 history, we took it way back to the Emancipation.
- 2 We talked about slavery, we talked about how we got
- 3 here in the city of Detroit. We walked through the
- 4 13th Documentary, we talked about the 13th Amendment
- 5 to the Constitution. We talked about the inception
- of the Detroit Police Department back in 1865. We
- 7 talked about the Malice Green incident. What we did
- 8 was give them an opportunity to understand where
- 9 some of the anger may be coming from from the
- 10 citizens for which they police. Out of that there
- 11 was a six-hour forum. A lot of hot moments from
- 12 both sides, but what it ended up having and being a
- 13 benefit for us is to give some of these officers who
- 14 were not alive during this time when all these
- things happened, the '68 riots, things of that
- 16 nature, give them a birdseye view of what's going
- 17 on.
- 18 So what ends up happening is when they're
- 19 out there confronted every day on traffic stops by
- 20 this anger, it gives them a sense of better
- 21 understanding of where the anger comes from. And
- 22 that worked out very successful for us. We have the
- 23 officers really begging to do it again. We plan on
- 24 doing something in the near future with regard to
- 25 that.



- 1 We hold weekly Zoomings, even though
- 2 we've been in this COVID situation, we've had about
- 3 30 Zoom meetings since the inset of the COVID,
- 4 that's been going great. As I mentioned, the
- 5 community groups at the beginning of this meeting,
- 6 they're constantly on the meetings every week.
- 7 As far as NPOs during this COVID, we
- 8 still had the opportunity to give some smiles on
- 9 faces to some graduates who actually graduated who
- 10 didn't get the opportunity to go to the facilities
- 11 at their prospective schools, we held ten graduation
- 12 parades, we've disbursed over 500 PPEs to the
- 13 citizens, and we continue to work with community
- 14 every day to make it a better place for both law
- 15 enforcement and the citizens.
- 16 And that, Board, concludes my report.
- 17 Any questions?
- 18 CHAIRPERSON BELL: Thank you, Commander.
- 19 COMMISSIONER BURCH: Yes, Mr. Chair.
- 20 CHAIRPERSON BELL: Yes, ma'am.
- 21 COMMISSIONER BURCH: Thank you.
- 22 Commander, you're in my door. This is Commission
- 23 Burch, but then you knew me as Shirley Burch in the
- 24 11th Precinct.
- 25 COMMANDER EWING: Yes, ma'am.



- 1 COMMISSIONER BURCH: What year were you
- 2. with us?
- 3 COMMANDER EWING: Ms. Burch, you know, I
- was with you several times. I was there as a 4
- 5 lieutenant, I was there as sergeant-lieutenant and a
- 6 commander twice. So I was there for the majority of
- 7 my career.
- 8 COMMISSIONER BURCH: That's what I
- 9 thought. Oh, my gosh, I just want to say wonderful,
- excellent report, but I wanted to ask you when you 10
- mentioned the door knocker, have you ever included 11
- 12 the crime stoppers, because they have a program of a
- 13 door knocker also. Have you included them in your
- 14 program?
- COMMANDER EWING: So their door knocker 15
- 16 is separate from ours. We give out both, but ours
- is more geared towards answering the community 17
- complaints. So If NPOs go out to a location, 18
- 19 someone calls and says maybe there's a barking dog
- or there's a neighbor dispute, we go knock on the 20
- door and they're not at home, the door knockers know 21
- that we actually came by and we visited. It gives 2.2
- 23 them an opportunity to know that the police answered
- their call. It gives a number to get back in 2.4
- 25 contact with us so we can service you.



- 1 COMMISSIONER BURCH: Okay. Thank you.
- 2 Commander, do you remember his name? He's
- 3 Investigator Cromwell.
- 4 COMMANDER EWING: Yes.
- 5 COMMISSIONER BURCH: At that time there
- 6 was a harassment regarding what Commissioner Brown
- 7 was saying about the parking enforcement, how they
- 8 used to come in the neighborhood and give citizens
- 9 tickets when they were parked where, for instance,
- 10 it was a berm. Do you remember some of that
- 11 instance that you came to the rescue with your
- 12 professionalism and your fairness to help the
- 13 citizens, do you remember that?
- 14 COMMANDER EWING: I don't remember that
- 15 specifically, Ms. Burch. I know you and I had a
- 16 number of conversations when I was there as a
- 17 commander. You kept me on task on a regular basis.
- COMMISSIONER BURCH: No, no, you kept --
- 19 don't say that. Don't say that, no. No, it's just
- 20 that we worked together just like you're doing in
- Number 5.
- 22 COMMANDER EWING: Yes, ma'am.
- COMMISSIONER BURCH: You know, that was
- 24 during the era of Mildred Kyle.
- 25 COMMANDER EWING: Yes.



- 1 COMMISSIONER BURCH: So, I'm saying I
- 2 come from a tutelage of watching women and men work
- 3 together. I just miss you and I'm glad to hear your
- 4 voice. I have often said where is Commander Ewing.
- 5 Now I know you're in Number 5.
- 6 COMMANDER EWING: Thank you, Ms. Burch.
- 7 COMMISSIONER BURCH: So God bless you.
- 8 COMMISSIONER HOLT: Through the chair.
- 9 CHAIRPERSON BELL: Commissioner Holt.
- 10 COMMISSIONER HOLT: Thank you, Commander
- 11 Ewing, for your presentation and Captain Williams as
- 12 well. You mentioned that you had been having --
- 13 your precinct has been having community relations
- 14 Zoom meetings, did I understand that?
- 15 COMMANDER EWING: Yes, ma'am.
- 16 COMMISSIONER HOLT: To whom do I know to
- 17 receive an invitation to those meetings?
- 18 COMMANDER EWING: You're looking at him
- 19 right here.
- 20 COMMISSIONER HOLT: Okay. So I can,
- 21 what, text you, call you?
- 22 COMMANDER EWING: Yes, just send me your
- 23 email address and I'll include you in.
- 24 COMMISSIONER HOLT: Okay, thank you a
- 25 lot. I appreciate that.



- 1 COMMANDER EWING: No problem.
- 2 CHAIRPERSON BELL: Any other
- Commissioner? 3
- I want to thank you, Commander Ewing. 4
- Make sure that we get the information because I've 5
- been guilty of not attending. Would you share that 6
- with Mrs. White and any other commissioner who might 7
- want to drop in? We try to establish that type of 8
- 9 rapport, and I need to pick it up because you are my
- commander. And, Captain Williams, thank you. 10
- You've been very professional since we met when we 11
- 12 was at the academy.
- 13 CAPTAIN WILLIAMS: Appreciate that.
- 14 CHAIRPERSON BELL: I'm glad you're on
- 15 this side of Detroit.
- 16 CAPTAIN WILLIAMS: Thank you.
- 17 CHAIRPERSON BELL: Thank you. I hope to
- interact with both of you in the near, near future, 18
- perhaps as soon as friday. Thank you. 19
- We're going to move on to Ms. White, the 20
- 21 Board Secretary.
- 2.2 SECRETARY WHITE: Yes, thank you,
- 23 Chairperson Bell.
- On the Board, if you could please refer 24
- to your agenda and your Tuesday packet for this 25



- 1 week, and I will simply highlight a few of the items
- 2 listed in the incoming correspondence for a complete
- 3 list of all of the incoming correspondence, but I'll
- 4 just go through a few items. And they are as
- 5 follows: 2 through 5, correspondence from Chief of
- 6 Police, James E. Craig regarding implicit training
- 7 bias, providing an overview of the department's
- 8 training curriculum, the program outlines for
- 9 implicit bias training and the required number of
- 10 hours for training and participation in both the
- 11 implicit bias training and the full training
- 12 curriculum for the DPD.
- 13 Number 3, letter from Chief of Police,
- 14 James E. Craig regarding the recommendation to
- 15 promote to the rank of detective, which was already
- 16 discussed earlier.
- Number 4, correspondence regarding Texas
- 18 Observer news article entitled, "How the San Antonio
- 19 Police are Re-thinking Mental Health," and this
- 20 correspondence was shared by a concerned citizen,
- 21 sharing program recommendations regarding mental
- 22 health professionals, responding to mental health
- 23 emergencies instead of first responders responding
- 24 to those mental health emergencies.
- 25 And Number 5 consists of a written



- 1 directive, 403.9, COVID-19 Department Policy, and
- 2 that was also included in your packet this week, and
- 3 the department transmitted that directive last week
- 4 and they are requesting for the Board's final
- 5 approval. Staff reviewed the policy on COVID-19,
- 6 and overall the directive is outlining the protocol
- 7 and procedures for department members' adherence
- 8 based on the Centers for Disease Control and
- 9 Prevention Guidelines. And so this directive is
- 10 providing department members with information on
- 11 precautions, expectations and procedures for all
- 12 department members to follow based on COVID-19
- 13 health precautions.
- The policy also covers, of course,
- 15 important definitions, procedures outlining
- 16 workplace precautions and symptomatic and COVID-19,
- 17 positive members, also indicating the procedures
- 18 with regards to members who are experiencing
- 19 COVID-19 related symptoms and measures, and all of
- 20 that information was contained in your Tuesday
- 21 packet, and there was a report again completed by
- 22 staff outlining what the policy consisted of. So at
- 23 this time I would request for a vote on the policy
- 24 directive on COVID-19 relating to the department's
- 25 transmitted directive.



1 CHAIRPERSON BELL: Commissioners. 2. COMMISSIONER HOLT: So moved. 3 COMMISSIONER HOLLEY: Support. 4 CHAIRPERSON BELL: It's been properly 5 moved and supported. Discussion? 6 Those in favor, yes? 7 COMMISSIONER HERNANDEZ: Yes. 8 COMMISSIONER HOLLEY: 9 CHAIRPERSON BELL: Those opposed, no. 10 Ms. White? 11 SECRETARY WHITE: Yes, the motion passed. 12 CHAIRPERSON BELL: Thank you. 13 SECRETARY WHITE: And Chairperson Bell, I also did have one last item with regards to the NACo 14 15 summaries. Again, staff has been attending the NACo 16 conference each week since the beginning of the NACo Conference. And I wanted to just give a brief 17 overview of some of the staff report that was 18 19 transmitted on last week, and additional reports are forthcoming based on the webinars that were provided 20 21 this week. 2.2 So just to highlight a few of the 23 sessions, one of them consisted of Implementing Procedural Justice, Strategies for Analyzing Police 2.4

Stops, and this particular workshop session

25

- 1 explained the concept of procedural justice which
- 2 focuses broadly on the extent to which people
- 3 perceive that they have been treated fairly and
- 4 respectfully during a police-citizen encounter.
- 5 The next session workshop that was
- 6 summarized included Community and Stakeholder
- 7 Engagement, Intensive Part One, emphasizing 13
- 8 principles of civilian oversight along with
- 9 strategies and tactics for maintaining effective
- 10 community involvement and community outreach.
- 11 The third session consisted of Community
- 12 and Stakeholder Engagement in Census Part 2,
- 13 highlighting principles of servant leadership,
- 14 community -- communicating effectively and other
- 15 core elements for effective communications and
- 16 engagement for oversight for law enforcement
- 17 agencies.
- 18 And the last summary consisted of
- 19 Evidence of Effect, Measuring and Reporting the
- 20 Impact of Oversight, Discussing the use of
- 21 Statistics and Quantitative Methods to help answer
- 22 key accountability questions with regards to
- 23 oversight agencies.
- And, again, we will transmit the
- 25 summaries from this week that consisted of the



- 1 following: The Use of Force, Calming a Crisis
- 2 Strategies to Reduce the Use of Force. Civilian
- 3 Oversight 101 was another workshop held, and then
- 4 the third workshop consisted of -- it was entitled,
- 5 "What Went Wrong. Deficiencies in the Investigation
- of an Officer-Involved Shooting." And, again, we
- 7 will make sure to transmit those summaries to you.
- 8 And thank you again to staff specifically and
- 9 including Investigator Tiffany Steward and all Board
- 10 of Police Commissioner staff for your cooperation in
- 11 developing those summaries. Thank you.
- 12 CHAIRPERSON BELL: Thank you, Ms. White.
- 13 Any questions for Mrs. White? If not, thank you,
- 14 Ms. White, once again.
- 15 Before we move on to unfinished business,
- 16 I just want to -- I forgot to acknowledge J.
- 17 Henderson, 5th Precinct Police Relations Chair; is
- 18 he still on the call?
- 19 COMMISSIONER HOLT: Community relations?
- 20 BOARD SECRETARY WHITE: We're looking for
- 21 him, Chairperson Bell.
- 22 CHAIRPERSON BELL: Ms. White, if you see
- 23 him, move him up to be Number One two-minute
- 24 speaker, please.
- 25 BOARD SECRETARY WHITE: Okay.



- 1 CHAIRPERSON BELL: If you see him, if
- 2. he's still on the call. I invited him to attend and
- 3 I know Commander Ewing acknowledged his presence. I
- forgot to speak to him. We want to give him that 4
- 5 opportunity.
- Also, Commissioner Griffie and 6
- 7 Commissioner Brown, can you hear me?
- COMMISSIONER BROWN: Yes. 8
- 9 COMMISSIONER GRIFFIE: Yes.
- CHAIRPERSON BELL: Could both of you join 10
- me in terms of the Chairman's remarks next week if 11
- 12 you're going to be in attendance?
- 13 COMMISSIONER GRIFFIE:
- 14 CHAIRPERSON BELL: Commissioner Brown.
- 15 COMMISSIONER BROWN: Yes.
- 16 CHAIRPERSON BELL: Thank you. The next
- item will be unfinished business. 17
- COMMISSIONER DAVIS: Mr. Chair. 18
- 19 CHAIRPERSON BELL: Commissioner Davis.
- 20 I know that the City COMMISSIONER DAVIS:
- 21 Council and their staff is not returning until the
- Coleman A. Young Municipal Building until the first 2.2
- 2.3 of the year. So my question to the Board is:
- this Board going to do the same for our staff and 2.4
- 25 the OCI staff? If not, when are we going to vote on



- 1 a date for the staff to return to work?
- 2 CHAIRPERSON BELL: We are working through
- 3 that now. We did not vote for them to leave. We're
- 4 complying -- we don't go by what others, we go by
- 5 primarily DPD, Detroit Police Department, and what's
- 6 been advised. So, we're working on that. We are in
- 7 the process of making sure all the staff is tested,
- 8 as you well know. Then from there we would probably
- 9 do a 50 percent in terms of staff reporting to make
- 10 sure we abide by the COVID issue and safety and
- 11 (inaudible). So that's what's in the plans now.
- 12 COMMISSIONER DAVIS: Okay. So right now
- 13 the staff has not fully returned?
- 14 CHAIRPERSON BELL: No, they are not.
- 15 They won't be fully returned any time soon. We're
- 16 looking at 50 percent. We're making sure -- first
- of all, they all have to be tested. We're going
- 18 through that process and we're also making sure that
- 19 we're in compliance. As you well know, DPD is up
- 20 and running. Also we're abiding by their format,
- 21 staff of the BOC is in place, but they're a much
- 22 smaller staff, as you well know, much smaller, but
- 23 they're making sure they adhere to all the policies
- 24 and stages of that process. Thank you.
- 25 COMMISSIONER DAVIS: So our staff is



- 1 there, but not the OCI, is that what you're saying?
- 2 CHAIRPERSON BELL: OCI is not there
- 3 except for a skeleton crew, administration is
- 4 working. That's about two or three individuals.
- 5 COMMISSIONER DAVIS: But our staff is
- 6 there?
- 7 CHAIRPERSON BELL: Our staff is in place,
- 8 that's correct.
- 9 COMMISSIONER DAVIS: Couldn't that be
- 10 dangerous?
- 11 CHAIRPERSON BELL: Sir, I just indicated
- 12 to you, we are following all the guidelines, we're
- 13 following all the guidelines in terms of abiding --
- 14 they've been in place for a couple weeks now, Ms.
- 15 White, two, three weeks.
- 16 SECRETARY WHITE: Yes, sir.
- 17 CHAIRPERSON BELL: We follow the
- 18 guidelines. We have to serve this community, so we
- 19 follow the quidelines.
- 20 Unfinished business. If not, new
- 21 business.
- 22 COMMISSIONER BURTON: Chairman, I had my
- 23 hand up for unfinished business.
- 24 CHAIRPERSON BELL: Yes, sir, go ahead.
- 25 COMMISSIONER BURTON: I'd like to move to



- 1 end the DPD's facial recognition.
- 2 COMMISSIONER DAVIS: Support.
- 3 CHAIRPERSON BELL: Once again, for the
- 4 umpteenth time, the motion is out of order. We do
- 5 not have any authority to act on that motion.
- 6 Therefore, the motion is not in order.
- 7 COMMISSIONER BURTON: Mr. Chairman, point
- 8 of order, City Council is in charge of budgetary,
- 9 but the Detroit Board of Police Commissioners is in
- 10 charge of administration oversight of the Detroit
- 11 Police Department.
- 12 CHAIRPERSON BELL: Commissioner Burton,
- if you want to send me some documentation to
- 14 challenge what we have already been indicating to
- 15 you, then you are free to put that in writing.
- 16 Thank you.
- 17 COMMISSIONER BURTON: Is the board
- 18 attorney available; can he respond to it?
- 19 CHAIRPERSON BELL: No, he's not. Thank
- 20 you.
- 21 COMMISSIONER BURTON: Would you like for
- 22 the Board attorney to respond?
- CHAIRPERSON BELL: We're moving on, sir.
- New business. Ms. White, we have an
- 25 issue with collision shop.



- 1 COMMISSIONER BURCH: Wait, I have new
- 2. business.
- 3 CHAIRPERSON BELL: Yes, ma'am. I'm
- 4 sorry. Do you have an announcement?
- 5 COMMISSIONER BURCH:
- CHAIRPERSON BELL: Wait for the 6
- 7 announcement, please. Thank you.
- SECRETARY WHITE: Yes, sir, I also wanted 8
- to indicate to the Honorable Board that the Board's 9
- office did receive unfortunately a letter of 10
- resignation from Ms. Delane Richards, our legal 11
- assistant. And so I did also want to indicate that 12
- 13 to the Honorable Board. So we wish her well.
- 14 CHAIRPERSON BELL: Thank you. So under
- 15 new business, collision, is that still on the
- 16 agenda?
- 17 SECRETARY WHITE: Yes.
- 18 CHAIRPERSON BELL: Ms. White, are you
- going to bring that forth? 19
- SECRETARY WHITE: Yes, and Captain 20
- 21 Parrish is also on the line.
- CHAIRPERSON BELL: I guess we'll hear 2.2
- from Captain Parrish first. We have documentation 2.3
- 2.4 that's been sent out to the Board; is that correct?
- 25 SECRETARY WHITE: Yes, sir.



- 1 CHAIRPERSON BELL: Thank you. Captain
- 2. Parrish.
- 3 SECRETARY WHITE: Captain Parrish, your
- microphone is unmuted. 4
- CHAIRPERSON BELL: Are you in the process 5
- of admitting Mr. Wyrick, Attorney to the Board? 6
- 7 SECRETARY WHITE: Yes, his microphone is
- also unmuted, and through the Chair we can move to 8
- 9 Attorney Wyrick while we contact Captain Parrish.
- 10 CHAIRPERSON BELL: Thank you.
- 11 SECRETARY WHITE: Attorney Wyrick.
- ATTORNEY WYRICK: Good afternoon. 12
- 13 CHAIRPERSON BELL: Okay, thank you.
- 14 ATTORNEY WYRICK: Can you hear and see
- 15 me?
- 16 CHAIRPERSON BELL: We hear you, we don't
- 17 need to see you.
- ATTORNEY WYRICK: Okay. 18
- 19 CHAIRPERSON BELL: (Laughing) Thank you.
- 20 MS. WHITE: Attorney Wyrick.
- 21 ATTORNEY WYRICK: Yes. May it please
- this Honorable Body, this is a new matter of B and F 22
- Collision. You may recall that they had a hearing 23
- previously a couple months ago in June of 2020, a 24
- couple months ago. This hearing basically, it 25



- 1 involves -- and I'll go through the summary that was
- 2 sent to the Board a couple days ago. Actually on
- 3 March 11, 2020 a tower, a 15 year employer by the
- 4 name of Edward Moody, took a laptop and Mac book
- 5 computer home from a vehicle he had towed. He lives
- 6 in the area of Evergreen in the city of Detroit,
- 7 48228. The laptop actually belonged to a young man
- 8 whose mother's car was stolen that he was driving.
- 9 The young man who owned the laptop used a Find My
- 10 Application to find the location of the tow truck
- 11 driver's home. From there police were actually sent
- 12 to the home basically to retrieve the laptop.
- 13 The two issues here is whether or not is
- 14 there substantial evidence that B and F Collision
- 15 violated the rules for police authorized towers,
- 16 and, two, did B and F maintain substandard protocols
- 17 within its towing operation by permitting employees
- 18 to remove personal property from vehicles and to
- 19 take the property home.
- 20 As I referenced, B and F Collision is
- 21 currently, pursuant to the Board's June 2020
- 22 decision, serving a 45-day suspension involving a
- 23 situation and involving a towing rotation whereby a
- 24 DPD officer was sending a disproportionate number of
- 25 tows to them between the years of 2017 and 2019, and



- 1 also that a particular officer also failed to
- 2 contact dispatch for a tow which more or less led to
- 3 the investigation. But those are facts separate and
- 4 aside from this one.
- 5 Under the rules for police authorized
- 6 towers, it states very specifically and is City
- 7 Code, 55-2, "The City may immediately terminate any
- 8 towing permit with a tow company for fraud or
- 9 criminal conduct by the tow company or its
- 10 employees." So really the question here is whether
- or not B and F through his particular employee
- 12 committed any type of fraud or criminal conduct.
- 13 It's important to know, however, that on May 19,
- 14 2020, the Wayne County Prosecutor's office did deny
- 15 a warrant request for criminal conduct against this
- 16 driver due to insufficient evidence. However, in
- 17 talking to Captain Parrish, my understanding is that
- 18 the Department has actually continued to press the
- 19 Wayne County Prosecutor's office for a possible
- 20 criminal case. So Captain Parrish may want to speak
- 21 to that in a few minutes.
- It's also important to note, from the
- 23 standpoint of analysis, that in conducting an
- 24 investigation, Officer Young from the Detroit Police
- 25 Department contacted ten different tow companies



- 1 within the city of Detroit, which I have listed in
- 2 my report. I won't name them all, but all of them
- 3 prohibit employees from taking the personal property
- 4 of others home.
- 5 The Detroit Police Department
- 6 recommendation is for the BOPC to basically have a
- 7 hearing on this and to make a decision. They
- 8 recommended that the permit be terminated. My
- 9 recommendation is that the BOPC conduct a hearing
- 10 and also once that hearing is conducted, then the
- 11 BOPC can (lost audio).
- 12 CHAIRPERSON BELL: Thank you, Attorney
- 13 Wyrick and we do see you now. Thank you. Captain
- 14 Parrish.
- 15 CAPTAIN PARRISH: Yes, can the Board hear
- 16 me?
- 17 CHAIRPERSON BELL: Yes, sir.
- 18 CAPTAIN PARRISH: Very sorry for that.
- 19 The computer was not working for me, so I'm
- 20 operating off the cell phone. Just to echo the
- 21 sentiments of Attorney Wyrick, the department's
- 22 position at this point in time is that there is
- 23 substantial evidence of violations of the rules for
- 24 police authorized towing, and that the matters at
- 25 issue are of sufficient gravity to potentially



- 1 warrant termination of the police authorized tower's
- 2 permit. So, therefore, we are petitioning the Board
- 3 to hold a hearing on this matter.
- 4 There is a criminal matter pending, a
- 5 warrant against the involved tow truck driver. It
- 6 was submitted to the Wayne County Prosecutor's
- 7 Office. However, the award was initially denied,
- 8 but based on new evidence, has been resubmitted and
- 9 we are told that we'll have a final determination on
- 10 that matter in approximately one week. So,
- 11 hopefully, when we return, that matter will be
- 12 resolved.
- However, the issue at hand is not just
- 14 the employee, but the company itself, which is what
- 15 we'd like the Board, in addition to hearing the
- 16 matter of the employee, for the Board to hear the
- 17 circumstances surrounding the practices of the
- 18 company in general. So with that, we would like to
- 19 recommend the Board convene a hearing on this
- 20 matter.
- 21 CHAIRPERSON BELL: Ms. White, could we
- 22 schedule that hearing at our next session next week;
- 23 is that feasible?
- 24 SECRETARY WHITE: Yes, sir.
- 25 COMMISSIONER GRIFFIE: Through the chair,

- 1 CHAIRPERSON BELL: Yes, ma'am.
- 2. COMMISSIONER GRIFFIE: I just want to say
- 3 that this it very concerning that we keep having to
- go into session to talk about this company, and I 4
- 5 look forward to the hearing because I really want to
- put this issue to bed. Frankly, they keep putting 6
- 7 us in this spot, when we have vendors that don't
- 8 want to cooperate by the rules.
- 9 CHAIRPERSON BELL: Right. Wouldn't this
- 10 be an open-type hearing?
- 11 ATTORNEY WYRICK: Yes, it could be, yes.
- CHAIRPERSON BELL: Yes, okay. I think 12
- 13 that would be a public hearing on this matter. It
- 14 doesn't meet the requirement for a closed session.
- We'll check into that. We hope to follow that 15
- 16 process. Duly noted.
- 17 COMMISSIONER BROWN: Through the Chair.
- 18 CHAIRPERSON BELL: Yes, sir.
- 19 COMMISSIONER BROWN: Just a quick
- 20 question. My memory just escapes me, but didn't we
- 21 vote to suspend his license?
- 2.2 ATTORNEY WYRICK: As I stated and as it
- 23 reflects on page 3 of my report, this same towing
- 24 company on a separate issue was just before the
- 25 Board in June of 2020, and at that time the Board



- 1 issued a 45 day suspension for a separate incident.
- 2 COMMISSIONER BROWN: And that 45 days has
- 3 been served?
- 4 ATTORNEY WYRICK: I believe it was. I
- 5 guess we would have to count from the exact date
- 6 that the suspension started in June.
- 7 CAPTAIN PARRISH: The company was
- 8 suspended following the Board's issuance of that
- 9 suspension. They were reinstated after the 45-day
- 10 period, and so they are currently on the police
- 11 authorized towing rotation.
- 12 CHAIRPERSON BELL: Okay. That's why
- 13 you're requesting this action.
- 14 CAPTAIN PARRISH: Thank you.
- 15 CHAIRPERSON BELL: We will have that
- 16 hearing next week then.
- 17 COMMISSIONER HOLLEY: Mr. Chairman, under
- 18 new business.
- 19 CHAIRPERSON BELL: Yes, sir.
- 20 COMMISSIONER HOLLEY: Mr. Chairman, under
- 21 new business and I'm not talking about nobody, I'm
- 22 just talking about what I'm talking about, and that
- 23 is that I'm just -- what about members suing? I
- 24 need to know from the law department if it's a
- 25 conflict of interest for one of our own to be --



- 1 just is it a conflict to be sitting and the person
- 2 is suing the Commission and the city, is it a
- 3 conflict? I'm just asking.
- 4 CHAIRPERSON BELL: Can you elaborate?
- 5 COMMISSIONER HOLLEY: My understanding is
- 6 that we've been sued by one of our board members. I
- 7 want to know -- I saw it in the news. Are you not
- 8 aware of it?
- 9 CHAIRPERSON BELL: By who? I'm not
- 10 aware, perhaps Ms. White can look into that and we
- 11 can report back to the Board as soon as possible.
- 12 SECRETARY WHITE: Yes, sir.
- 13 CHAIRPERSON BELL: Thank you. Thank you,
- 14 Commissioner Holley, for bringing that to my
- 15 attention. Announcement. Commissioner Burch.
- 16 COMMISSIONER BURCH: Yes, it's my turn?
- 17 CHAIRPERSON BELL: Yes, ma'am.
- 18 COMMISSIONER BURCH: I wanted to announce
- 19 to everybody 1200 jobs are coming to District 3.
- 20 There's going to be tonight at 6 o'clock, Mayor
- 21 Duggan will be on the Zoom conference regarding the
- 22 distribution center which is called Amazon will be
- 23 up at the State Fairgrounds. Also the MDOT is going
- 24 to have a center there or busses there, okay. So I
- 25 think that's pretty good news for the area.



- 1 Everybody hear that? You can go on the website to
- 2 listen--
- 3 CHAIRPERSON BELL: It's great news, great
- 4 news.
- 5 COMMISSIONER BURCH: All right. I just
- 6 wanted to share that news with everybody.
- 7 CHAIRPERSON BELL: Thank you.
- 8 COMMISSIONER BURCH: Thank you.
- 9 CHAIRPERSON BELL: The next meeting will
- 10 be on Thursday, August 20, and thereafter, we'll be
- 11 meeting August 27, same time, at 3 P.M. They both
- 12 will be virtual.
- Now we move on to oral communication from
- 14 the audience. Mr. Brown, is J. Henderson still with
- 15 us or not?
- 16 SECRETARY WHITE: Ms. Blossom.
- 17 CHAIRPERSON BELL. Ms. Blossom, I'm
- 18 sorry.
- MS. BLOSSOM: Good afternoon,
- 20 Mr. Chairman, you have ten speakers, and I will call
- 21 them in the sets of three and just to reiterate the
- 22 two-minute time limit. We first have Mr. Eric
- 23 Blount.
- 24 CHAIRPERSON BELL: Ms. Blossom, if I may
- 25 interrupt you. Is J. Henderson still on the call?



- 1 Do you see a J. Henderson?
- 2 SECRETARY WHITE: No, sir, I looked for
- 3 him earlier, unless he's come back. Let me double
- 4 check.
- 5 Mr. Henderson has left the room.
- 6 CHAIRPERSON BELL: Thank you. We can
- 7 move on. Mr. Blount, I guess.
- 8 SECRETARY WHITE: Mr. Blount.
- 9 MR. BLOUNT: Yes, can you hear me, Board?
- 10 CHAIRPERSON BELL: Yes, sir.
- MR. BLOUNT: Yes, good afternoon. For
- 12 the record my name is Eric Blount. I'm a minister
- 13 at Sacred Heart Catholic Church here in Detroit and
- 14 I'm a life-long Detroiter.
- This national survey revealing an all
- 16 time low in regards to public confidence in police
- 17 departments is no surprise, and it's growing lower
- 18 each day here in Detroit. And let me give you just
- 19 two examples that surfaced here in this meeting.
- 20 Director Graveline agreed to supply the
- 21 video of protesters' interaction with police, but
- 22 not to the public. When DPD knows it's in the
- 23 right, then the body-worn camera videos can be
- 24 released within hours, not weeks, not months, not
- 25 years, as in the case of Duane Jones, who viciously



- 1 beat a naked woman in the hospital. The bystander's
- 2 video is the reason why we know of this police
- 3 brutality.
- 4 Secondly, as far as officers' discipline
- 5 is concerned, all 12 officers' names and the reason
- 6 why they are on discipline should be revealed. If
- 7 the Wayne County Prosecutor can release 35 officers
- 8 in the Brady-Giglio policy; then why can't DPD
- 9 release the 12 officers' names, the reasons why they
- 10 are included, the additions and the removals and the
- 11 reasons why?
- 12 Lastly, the protesters demand for firing
- 13 Chief Craig and Duggan and defunding the police is
- 14 nothing to laugh at. These people, young, old,
- 15 black, white, suburban and Detroiters are putting
- 16 their bodies on the line for what they believe are
- 17 needed changes to ensure that all people are awarded
- 18 life, liberty and the pursuit of happiness. I yield
- 19 my time.
- 20 SECRETARY WHITE: The next speaker is
- 21 Justice for Robert and Mike, and he'll be followed
- 22 by Ashley Smith.
- MR. DELLICOLLI: This is Anthony
- 24 Dellicolli from Detroit DSA. Five or \$6,000 is an
- 25 up-front cost for businesses to participate in



- 1 Project Green Light. It's an obvious pay to play
- 2 shake down scheme. This is just one of the reasons
- 3 that Project Green Light needs to be ended. It's
- 4 time to move from a reactionary vision of safety
- 5 with more surveillance to a proactive and a
- 6 localistic vision of safety. It reinvests in things
- 7 like public housing and health resources. Why does
- 8 the Board waste time trying to weaponize DPD to
- 9 remove their neighbor's kiddie pools or their
- 10 church's parking lot or clean their church's parking
- 11 lot, but can't be bothered or hold them accountable
- 12 for shooting four Detroit citizens in the month of
- 13 July.
- 14 How does it take six hours for DPD
- 15 officers to understand why protesters are in the
- 16 streets? DPD officers themselves are the ones
- 17 showing up dressed in riot gear, to beat protesters
- 18 with batons, tear gas them, shoot them with
- 19 nonlethal beanbag rounds and run them over with
- 20 their SUVs. The video of the SUV incident needs to
- 21 be released to the public now. The fact that
- 22 members of this Board are laughing at the demands
- 23 being put forth by protesters is a clear indication
- 24 that this Board does not support the movement at
- 25 all. This is a joke.



- 1 Here's a list of American cities that
- 2 have banned facial recognition technology, San
- 3 Francisco, Austin, Oakland, Berkeley, Alameda, Santa
- 4 Crux. Somerville, Brooklyn, Cambridge, Springfield,
- 5 North Hampton, East Hampton, Portland, Maine.
- 6 Police commissioners in the city with the largest
- 7 percentage of black citizens, you all look
- 8 ridiculous for continuing to be complicit in the use
- 9 of this racist technology, refusing to ban it. You
- 10 all will be remembered for doing this on this Board.
- 11 Thank you.
- 12 CHAIRPERSON BELL: Thank you.
- 13 SECRETARY WHITE: Ashley Smith followed
- 14 by Megan S.
- MS. SMITH: Hi, my name is Ashley Smith.
- 16 I'm the sister of Shaunee Smith who was a victim of
- 17 police brutality in Detroit. Since I've been coming
- 18 to this meeting, to these meetings, there's not only
- 19 been a lack of accountability with the police
- 20 brutality that we saw for my sister, but there's
- 21 also been a number of other things that are
- 22 concerning to include use of facial recognition, you
- 23 know, the incident where unfortunately we had
- 24 citizens of Detroit and others, you know, with the
- 25 police car and there's a lack of accountability.



- 1 But unfortunately there's a lack of faith in DPD.
- 2 When you have a lack of faith in the police
- 3 department, then, you know, it creates -- it creates
- 4 an atmosphere in which, you know, things like this
- 5 are going to happen, and I stated that from the
- 6 first time I've been on these calls. It's very
- 7 important that we have accountability for incidents
- 8 such as the Duane Jones. Instead of promoting
- 9 police officers, people have lost faith and I hope
- 10 that there's some type of way that we can restore
- 11 faith and that we can hold these officers
- 12 accountable. Thank you.
- 13 CHAIRPERSON BELL: Thank you.
- 14 SECRETARY WHITE: Megan S. followed by
- 15 Erin Dwyer.
- MS. MEGAN: Good afternoon. My name is
- 17 Megan and I'm here with Detroit DSA. First I just
- 18 want to -- I actually thank you for being here every
- 19 week. I just want to say that the fellow
- 20 commentaries, we see you here every week. You don't
- 21 deserve to be going through this, to be begging for
- 22 some dignity for your sister, it's really unfair. I
- 23 just want to say, we see you and we hear you and we
- 24 support you.
- Commissioners, we've been here at Detroit



- 1 DSA for weeks and demand that you end Project Green
- 2 Light and ban facial recognition technology. And I
- 3 want you to know that we will not back down.
- 4 Although it has become incredibly depressing to
- 5 watch you shut down this demand brought forward by
- 6 Commissioner Burton week after week, we will not
- 7 back down. Facial recognition is a dragnet policing
- 8 strategy where we are all seen as criminals needing
- 9 to be surveyed. Project Green Light is a pay to
- 10 police surveillance network.
- To bring on someone from DPD to
- 12 essentially advertise Project Green Light today was
- 13 ridiculous. Surveillance does not make the city
- 14 feel safer. It makes us feel watched, scrutinized
- 15 and controlled. We did not consent to this use of
- our data by DPD or the federal agencies they share
- 17 data with. We are not criminals until proven
- 18 guilty, and we do not support DPD fishing for
- 19 criminals in our community. We will not back down
- 20 until you vote yes on Commissioner Burton's motions
- 21 to ban facial recognition technology and end Project
- 22 Green Light or another one of you commissioners
- 23 summons the courage to put forward the motion
- 24 yourselves. Thank you.
- 25 CHAIRPERSON BELL: Thank you.

- DR. DWYER: Good afternoon. I am Dr.
- 2 Erin Dwyer, a DSA member and a Detroit resident who
- 3 is frankly exhausted with this Board's apathy,
- 4 vanity, and overt democracy or transparency. It's
- 5 aggravating to me that some on this board are more
- 6 concerned about one single baby pool on a lawn and a
- 7 little drag racing than they are about police
- 8 murdering three black men in the same week or people
- 9 being wrongly imprisoned in a racially prejudice
- 10 software and Project Green Light. When a problem
- 11 arises in my neighborhood, I talk it out, involve my
- 12 community to resolve the problem, and I strengthen
- 13 that community. What I don't do is call the cops.
- 14 I live in a majority black neighborhood in Detroit

- The burden of proof shouldn't be on
- 22 Commissioner Burton to prove that it's out of BOPC
- 23 power to ban Project Green Light. Bell, you're the
- 24 one who keeps saying it, prove it. You bring
- 25 documents to next week's meeting.



- Meanwhile, Commissioner Hernandez talks 1
- about finding common purpose with his colleagues and 2.
- 3 the public. And please support your colleagues who
- have joined the public in calling for a ban on 4
- 5 Project Green Light, a ban on tear gas, rubber
- bullets and an end to DPD receiving military 6
- equipment through the 1033 program, and you call the 7
- release for the June 20th protest. 8
- Commissioner Hernandez speaks about 9
- finding common purpose and listening with kindness. 10
- If he had spoken with members of Hakeem Littleton's 11
- 12 family as I have, maybe he would join me in calling
- 13 for a full outside investigation into the murder of
- 14 Hakeem Littleton. I can't wait to vote for
- 15 Deborah Burke to take over Evette Griffie's seat
- 16 since Ms. Griffie can't even be bothered to attend
- 17 this meeting. I yield my time and look forward to
- 18 Tawanna Petty speaking soon.
- 19 BOARD SECRETARY: Ms. Cindy Darr followed
- by Mark Young of the Lieutenant and Sergeant's unit. 20
- 21 MS. DARR: Can you hear me?
- 2.2 CHAIRPERSON BELL: Yes, ma'am.
- 23 MS. DARR: Can you hear me?
- 2.4 CHAIRPERSON BELL: We can hear you.
- 25 MS. DARR: Okay, good. It seems like



- 1 even though you're passing the buck on the Green
- 2 Light, you can control police towing which I thought
- 3 was paid for through the City Council, they pay the
- 4 bills. How many people -- this is another topic.
- 5 How many community people got to come to those
- 6 workshops? I never heard about those, but those
- 7 should be community workshops for the police and the
- 8 community, not just the police, the ones that you

- 6 Mark Young followed by Tom Stevens who sent a
- 7 comment before the 4 P.M. deadline, and then
- 8 Michelle George, will be your last speaker.
- 9 CHAIRPERSON BELL: Thank you.
- 10 MR. YOUNG: Hello, can you hear me?
- 11 CHAIRPERSON BELL: Yes, sir.
- 12 MR. YOUNG: I just want to say thank you
- 13 to the awesome men and women that's out here every
- 14 day that's representing the Detroit Police
- 15 Department. From the top to the bottom, I want to
- 16 say thank you.
- I, too, am a citizen of the city of
- 18 Detroit, and I'm also a leader with over 33 years.
- 19 I want to say thank you. I need them to know that
- 20 this is a thankless and an unappreciated job, but
- 21 they serve and they work hard anyway, 109 CCW
- 22 arrests for the week. That's not something new,
- 23 that's something that they've always been doing.
- 24 I've heard some people saying over the last three
- 25 weeks, over the last four weeks, that's not



- 1 something new either. They still work through it,
- 2 agitators, protesters, COVID-19, tough times,
- 3 through the summer. They sacrificed their summer
- 4 with their families to provide for the citizens
- 5 while working up to 16 hours plus more a day.
- 6 They're emotionally exhausted, they're tired, but
- 7 still unappreciated.
- 8 Twenty members positive for COVID right
- 9 now, 30 members quarantined, still thankless. 24/7,
- 10 365, these men and women have busted their behinds
- 11 for the citizens of Detroit. Let's take a moment
- 12 and thank them and appreciate the job that they're
- out there doing under very difficult times while
- 14 Detroit shines, while other cities are going through
- 15 a turn for the worse. This is not something new for
- 16 us. We've always shined. We need to be more
- 17 thankful, more appreciative and more supportive.
- 18 Thank you.
- 19 CHAIRPERSON BELL: Thank you.
- 20 SECRETARY WHITE: Mr. Chairman, Mike
- 21 Shane also met the 4 P.M. deadline. Mr. Shane.

- 1 Detroiters. We have more Detroiters in our

- 4 include a number of attorney groups, including the
- 5 ACLU, the National Lawyer's Guild, the Detroit --
- 6 excuse me, the Wayne County Neighborhood Defenders
- 7 and the National Conference of Black Attorneys --
- 8 Black Lawyers, excuse me.
- 9 I'll just read a short statement that I
- 10 sent to the board a few days ago: "The Coalition
- 11 for Police Transparency and Accountability cc'd the
- 12 Board of Commissioners via e-mail last week, and
- 13 that letter was delivered to Michigan Attorney
- 14 General, Dana Nessel. The letter requested an
- 15 independent investigation by the AG into the killing
- 16 of Hakeem Littleton by officers of the Detroit
- 17 Police Department on July 10, 2020. We are
- 18 requesting that the Board of Police Commissioners
- 19 also investigate the circumstances surrounding the
- 20 killing of Hakeem Littleton.
- 21 The coalition produced a video, using
- 22 publicly available DPD bodycam videos and arrived at
- 23 a strikingly different conclusion that contradicts
- 24 that of Detroit Police Chief, James Craiq. This
- 25 should be sufficient cause to launch an independent



- 1 investigation into Mr. Littleton's death. The
- 2 Charter of the City of Detroit gives the Board of
- 3 Police Commissioners broad powers to conduct such an
- 4 investigation. Refer to Section 7-803 and 7-804 of
- 5 the current City Charter.
- 6 UNIDENTIFIED SPEAKER: Mr. Chairman, Tom
- 7 Steven's comment by the Internet Smart Sheet was to
- 8 encourage the protest and to object, call on fellow
- 9 Detroiters to insist that the police be subjected to
- 10 due process, oversight and accountability reform.
- 11 MS. GEORGE: Can you hear me?
- 12 CHAIRPERSON BELL: Yes, ma'am.
- MS. GEORGE: Hi, to Chairman Bell and I
- 14 want to say to the Board of Police Commissioners.
- 15 Chairman Bell, last week when I made the
- 16 comment about you being a police officer, I know you
- 17 are a citizen, but what I'm stating a lot of times
- 18 you think as a police officer. You'll always be one
- 19 in terms of decisions that you make. Just like I'll
- 20 always be a nurse, even though if I ever decide to
- 21 retire. But what I wanted to say, Lieutenant Mark
- 22 Young, we hear you, and I'm always in support of the
- 23 Detroit police officers. We know you put your lives
- on the line and we've got COVID-19. It's a balance;
- one has nothing to do with the other.



- 1 Just remember, the lynching of
- 2 George Floyd was a trigger event, and that's why I
- 3 commend Lieutenant Young, but I also commend Mr. --
- 4 Commander Ewing, thank you, because what he's doing,
- 5 he's bridging that gap when he talks about the
- 6 community and the 400 years our people have been
- 7 oppressed. So, I commend you also, Commander Ewing,
- 8 as well as Lieutenant Mark Young.
- 9 But I was the one that asked the deputy
- 10 chief, there have been four missing young ladies in
- 11 the last three months, and I wanted to know is there
- 12 any information on those young ladies?
- 13 I'm also concerned, Commissioner Griffie
- 14 and Chairman Bell, if you all have any power, and
- 15 Commissioner Griffie said she was going to shut down
- 16 the facial recognition, I have not heard from her,
- 17 and so I am concerned with that. Even though we may
- 18 not agree with a lot of things she said, she's still
- 19 a commissioner and we respect her, but she's been
- 20 quiet. So I hope she's not being quiet because of
- 21 what she stated, because she was right. But we're
- 22 praying that we would get a new administration, I
- 23 pray for that young lady, Ms. Smith, called in for
- 24 her sister. Corporal Jones had a responsibility to
- 25 go before that family. So you have to look at it



1	like that. That's why his name is going to continue
2	to be called out in the atmosphere. So thank you
3	for that's my comment.
4	CHAIRPERSON BELL: Thank you.
5	SECRETARY WHITE: Mr. Chair, that was
6	your last speaker today. Thank you.
7	CHAIRPERSON BELL: Thank you. If there's
8	no other business before this body, the chair would
9	entertain a motion to adjourn.
