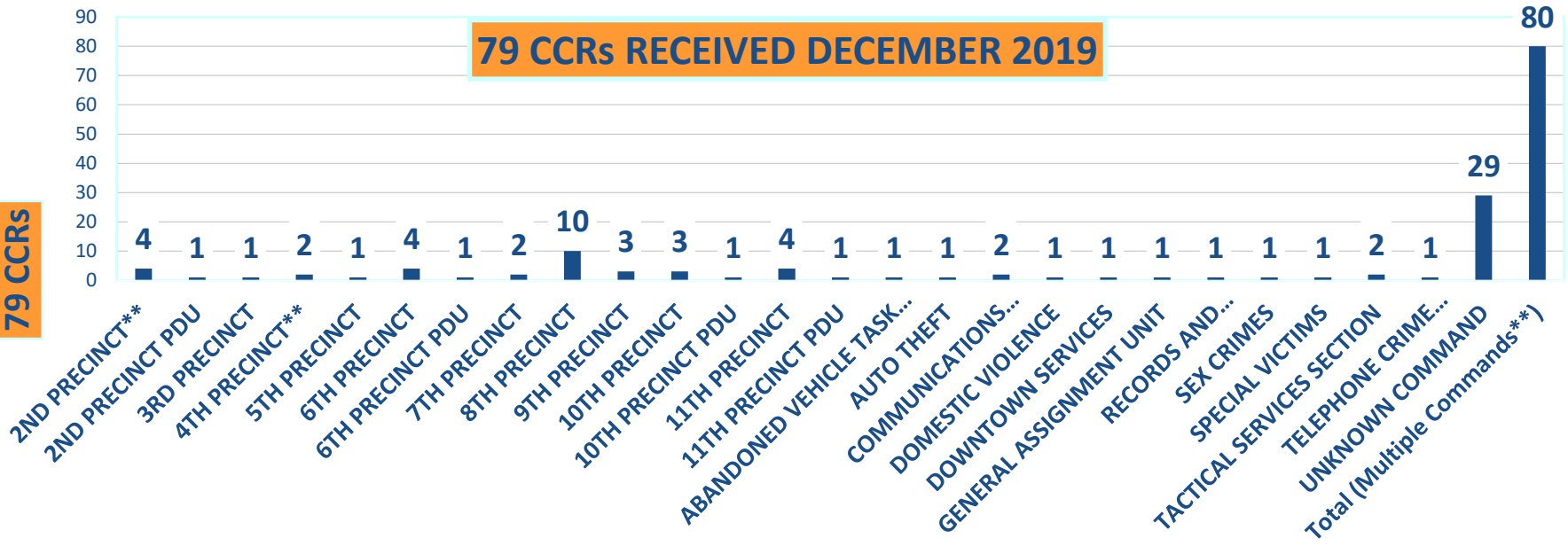

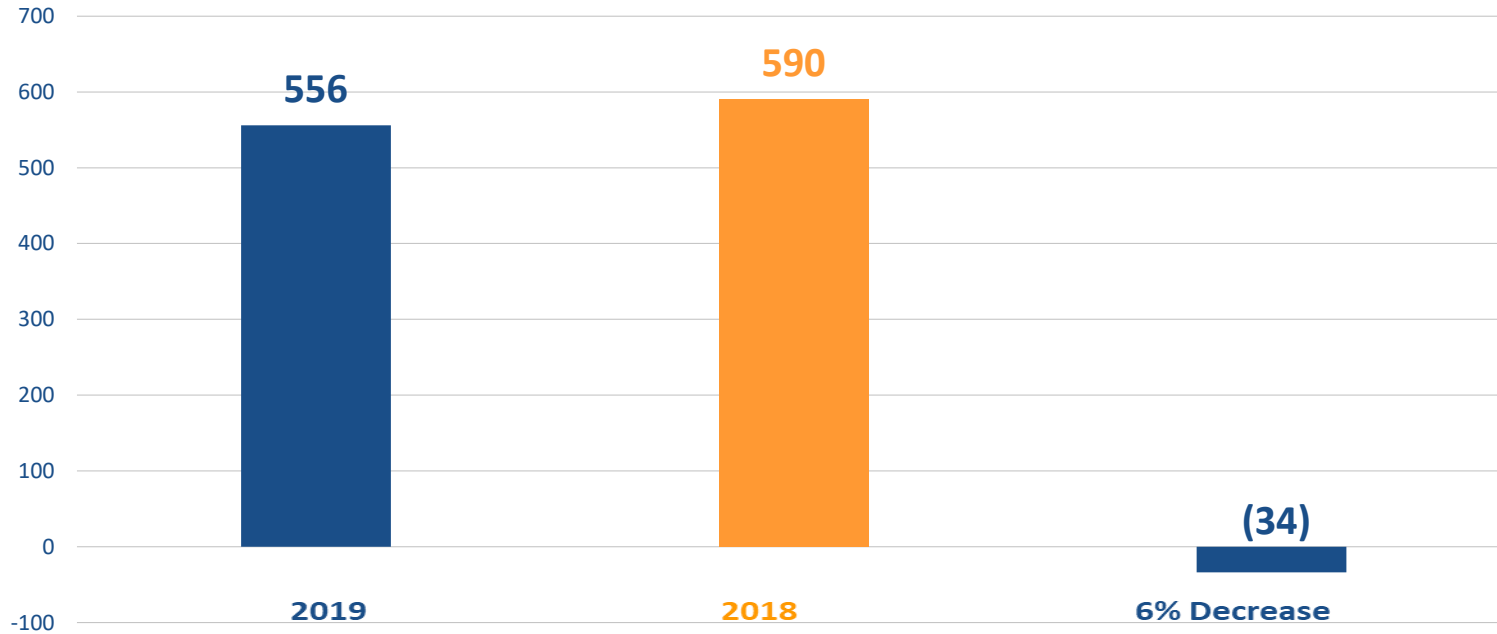

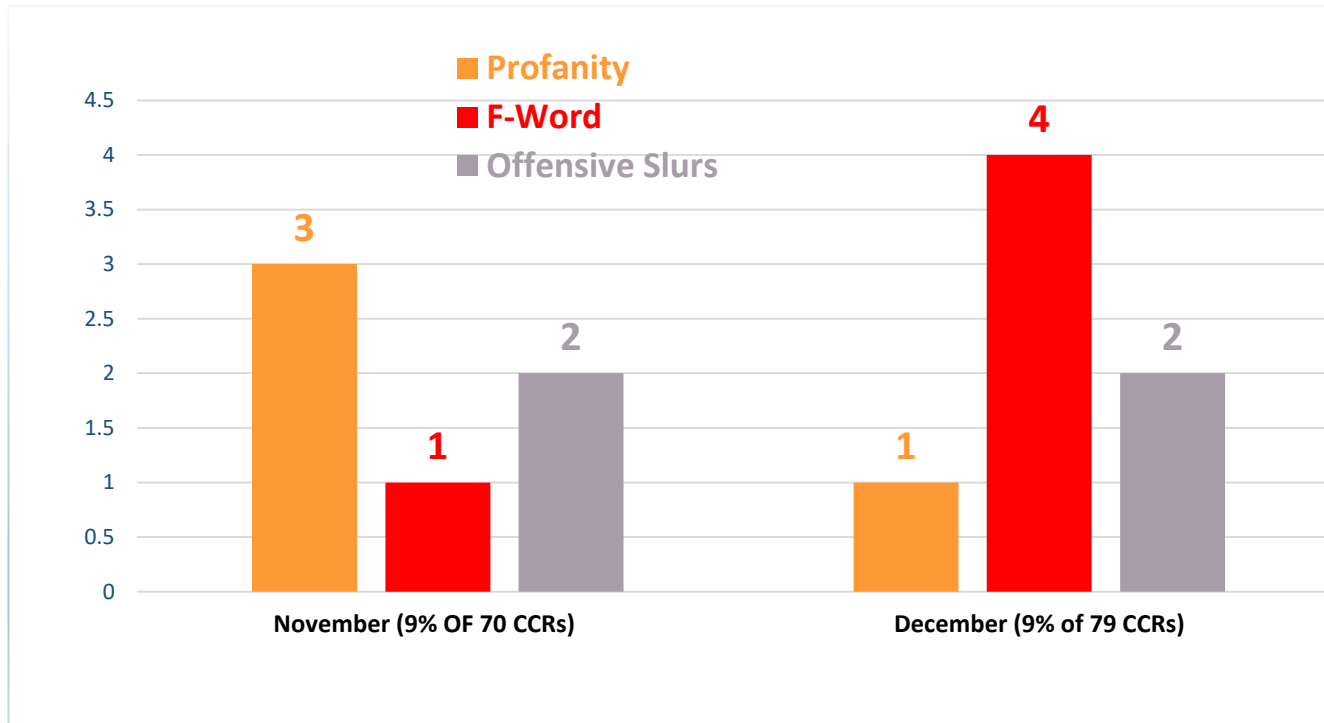
RECEIVED - DPD JULY TO DECEMBER 2019 vs 2018

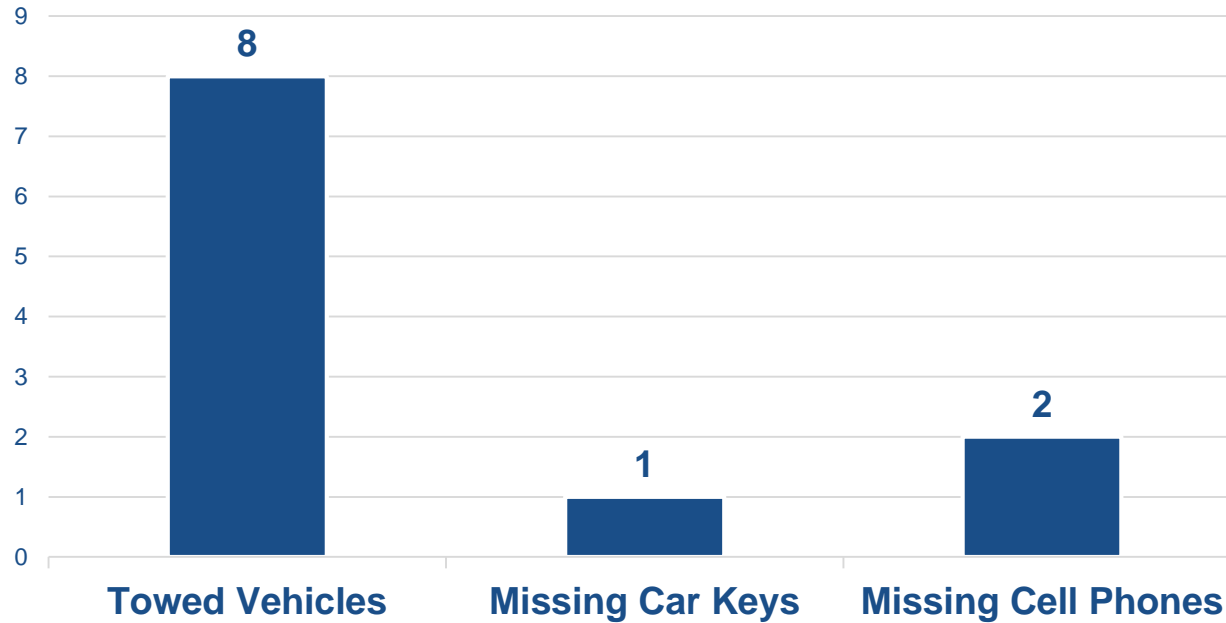

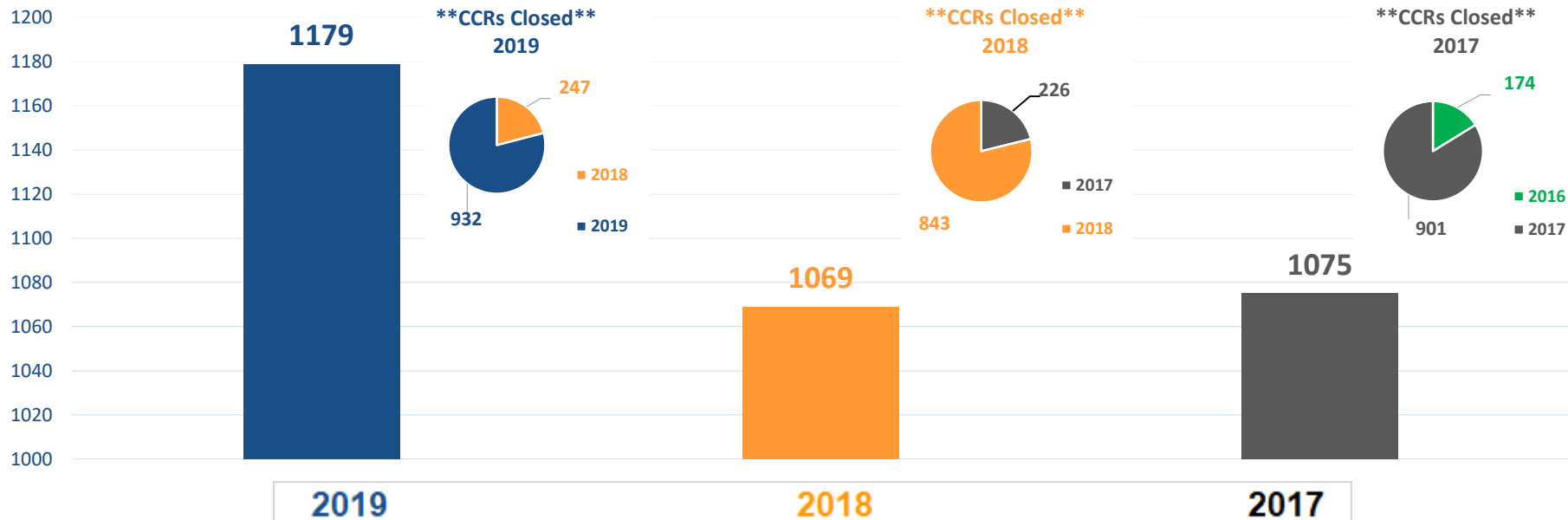

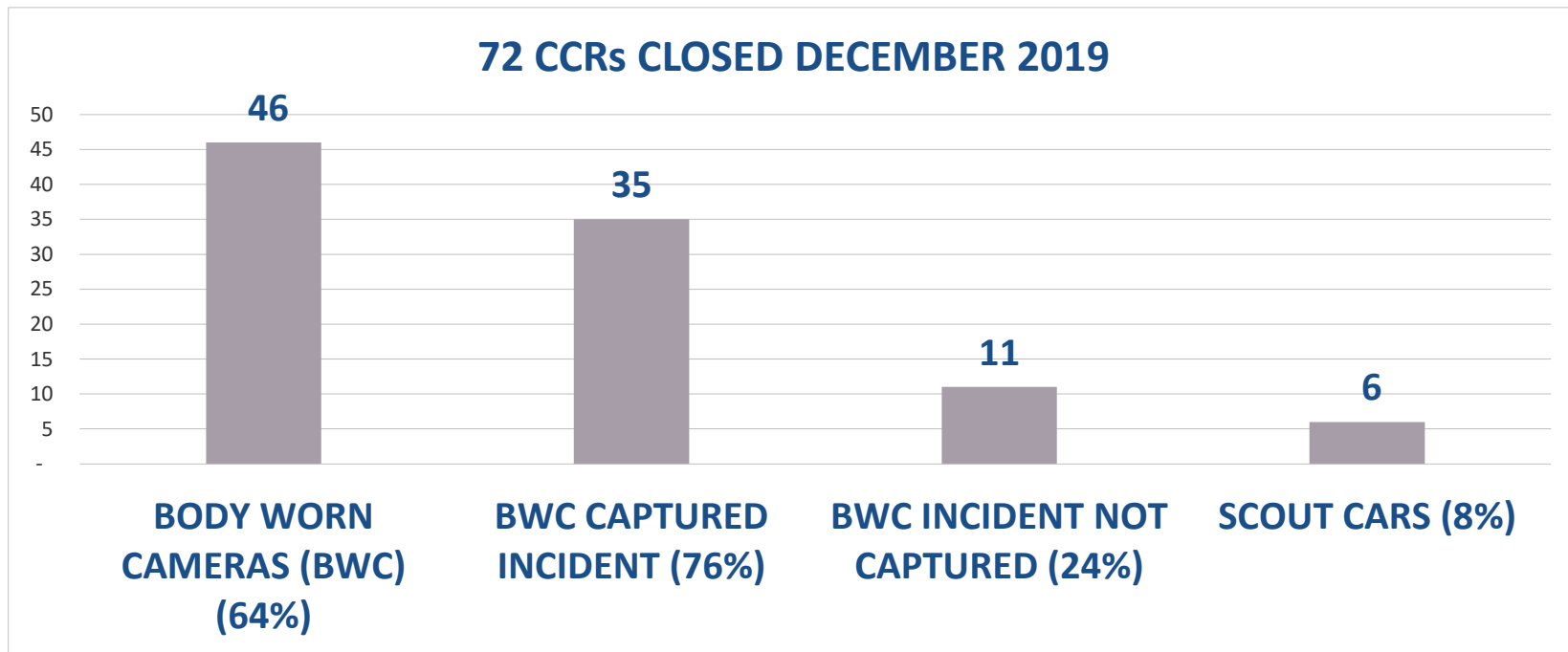

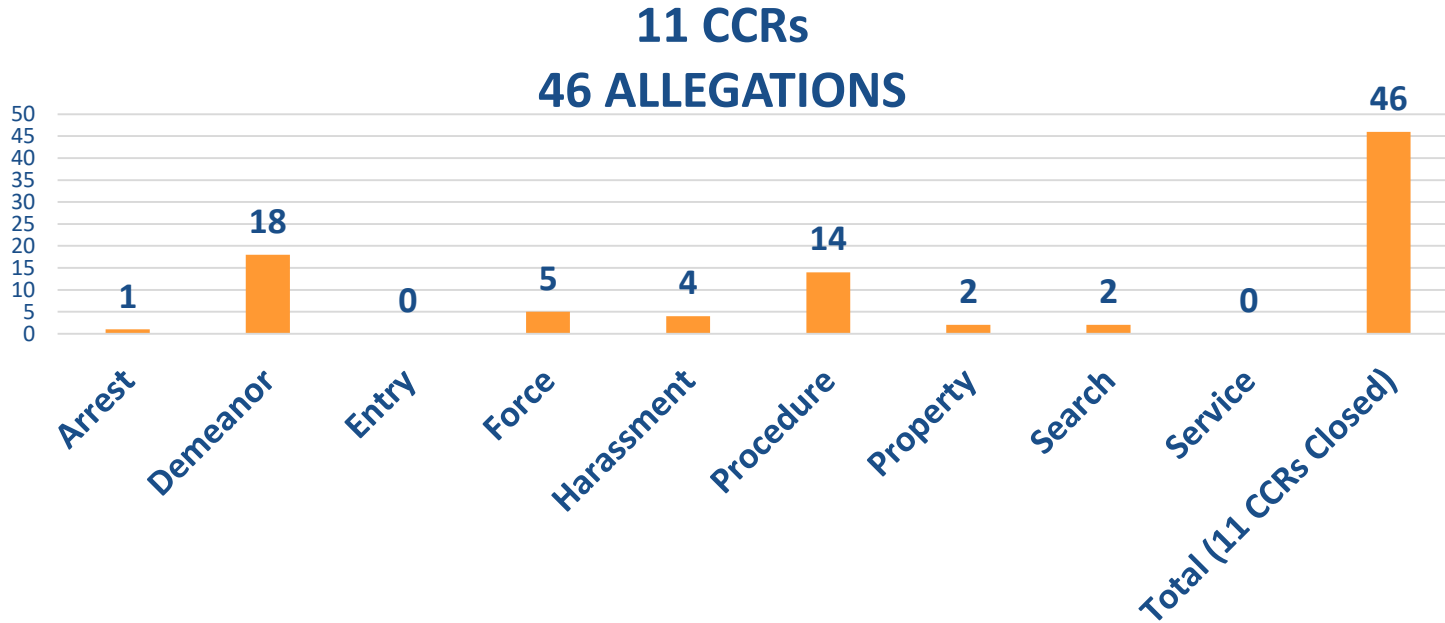

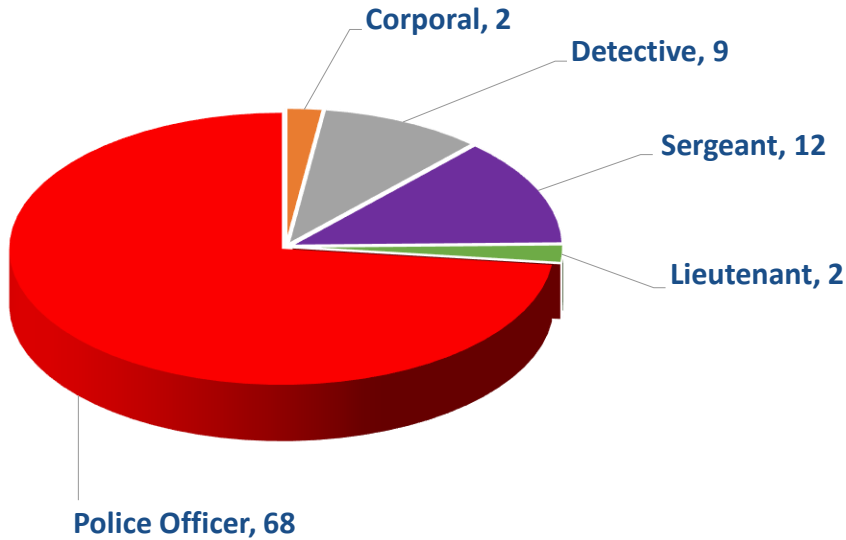

DPD MEMBERS BY SENIORITY & RANK

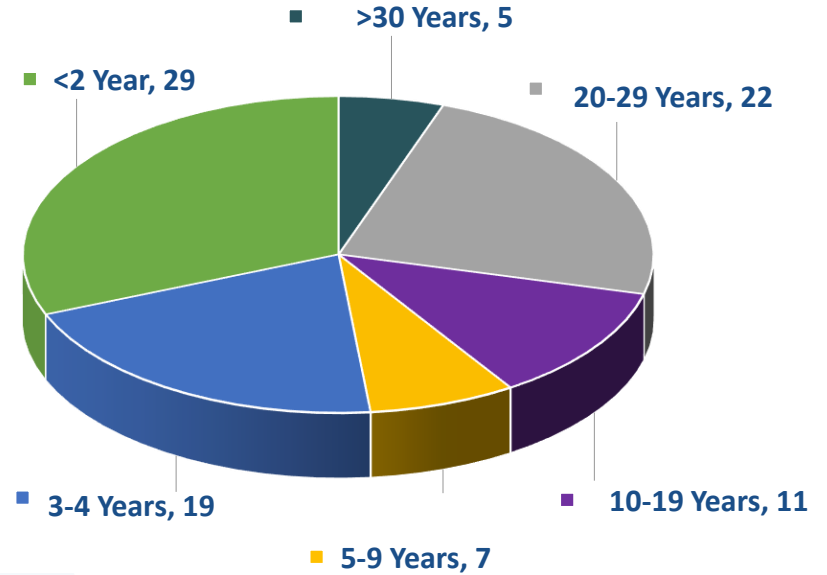
