- 1. Please briefly explain the Law Department's new expense initiatives, new capital funding requests, operational reform and savings proposals, and new revenue initiatives/proposals to be implemented in FY 2022. - 2. The OCFO's December 2020 monthly report shows 18 vacant positions for the Law Department. Please briefly describe the positions that are vacamt as of February 28, 2021 and any diffuculty of filling the vacancies. Also, please briefly explain the department's strategy to fill vacant positions.
- 3. The Mayor's FY 2022 recommended total appropriations for the Law Department is \$18.2 million a \$2.5 million increase from the \$15.7 million in FY 2021. The increase appears to be due to a \$2.1 million salaries expenses reduction in FY 2021 that is partially restored in FY 2022 and \$437,500 increase in legal services. Please explain the increases in salaries and legal services expenses.
- 4. Please briefly explain the position changes and any new positions for FY 2022.
- 5. Building rentals increased \$58,281 in FY 2022 to \$712,453 for Appropriation 29320 (Efficient and Innovative Operations Support Law). Why did this expense increase?
- 6. Please list the contracts which comprise the FY 2021 and FY 2022 professional and contractual services budgets for the Law Department. Please list the services that the contracted professional provides. Also, list the amount of the contract expected to be expended for each contract in FY 2021 and FY 2022.
- 7. What are the projections for litigation settlements and payments for FY 2021 and FY 2022? There was a reducation in litigation expenses for Police (\$9.5 millon) and Transportation (\$1.9 million) in FY 2020 compared to FY 2019. Are the mitigations that made this possible continuing in the current and future fiscal years?
- 8. What is the total number of open litigation cases against the City as of February 28, 2021 or the latest date where data is available? What is the total amount reserved for the open litigation cases?
- 9. On the revenue side, how much in lawsuit settlements and payouts revenue did the City benefit in the current fiscal year (FY 2021)? What other prosecution activities undertaken by the Law Department are expected to result in revenue or reimbursements to the City in FY 2021 and FY 2022?

The Law Department is headed by the Corporation Counsel, who is appointed by the Mayor with approval by City Council.

The Department is required by Charter to represent the City of Detroit in all civil actions or proceedings filed against the City. The Corporation Counsel may also prosecute any action or proceeding in which the City has a legal interest, and is the City prosecutor on cases arising from the provisions of the Charter or City ordinances and prosecute all actions for the recovery of fines, penalties and forfeitures. The Department provides advice and opinions to the Mayor, members of City Council or the head of any City agency, approving the form and substance of all contracts, bonds and written instruments, and drafting, upon the request of the Mayor or any member of City Council, any ordinance or resolution for introduction.


