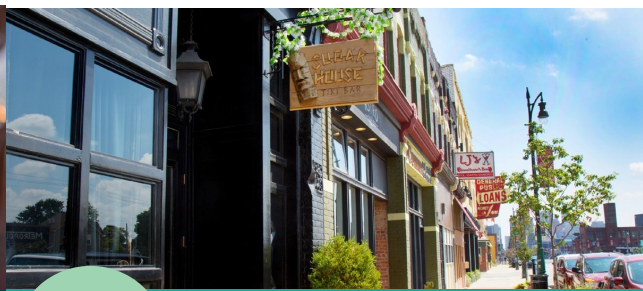

Step 1 Establish Your Business

The first step in obtaining a business license is to establish your business, use, & location

Obtain a building permit and Certificate of Occupancy!

Confirm your zoning requirements & [apply online](#) for your building permit.

Choose a name for you business or register your incorporated business:

◆ If using an assumed name, must file an application for an Assumed Name Certificate with Wayne County

Form is available at Wayne County Clerk's Office

◆ If you Incorporate Your Business: Register with the State of Michigan

Step 2 Now you are ready to apply

[Apply for your business license online.](#) You will need to submit the following documents:

- Proof of property ownership—lease (notarized) or land contract/property deed (registered with Wayne County)

Step 3 Get Ready to Open!

After you have submitted your application & supporting documents, you are almost there!

- Pay your business license fee

Payment can be made when filling out your online application.

Note: Receipt of payment is not a business license

Application will be reviewed for accuracy, identify missing documents, & provide a checklist of required approvals based on your business type. This may include:

- ◇ Certificate of Compliance
- ◇ Certificate of Occupancy (when permit is finalized)
- ◇ Finance information
- ◇ Fire inspection
- ◇ Environmental Health
- ◇ Food Safety Inspection
- ◇ Bond/Insurance
- ◇ Police

Remember:

Your business license should be renewed annually!

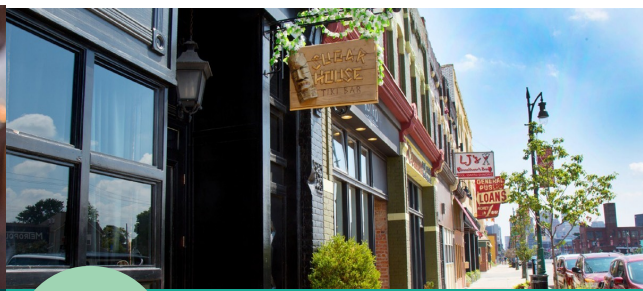

- ◆ Certificate of Compliance
- ◆ Certificate of Occupancy (when permit is finalized)
- ◆ Finance information
- ◆ Fire inspection
- ◆ Environmental Health
- ◆ Food Safety Inspection
- ◆ Bond/Insurance
- ◆ Police
