The Detroit Water and Sewerage Department (DWSD)'s Procurement Group is actively seeking to improve vendor participation in our solicitation process and to streamline our contract/purchase order process

DWSD's Solicitations for Procurement of Goods & Services

DWSD posts all solicitations (requests for bids, quotes, information, proposals etc.) on the Michigan Inter-governmental Trade Network (MITN) along with nearly 200 other local government purchasing departments to solicit vendor responses.

Vendors must select all relevant and applicable NIGP codes to allow for optimal access to opportunities.

City of Detroit Clearances

All potential and current vendors are required to apply, obtain and **maintain** City of Detroit Income Tax & Revenue clearance certificates.

Income Tax and Revenue Clearances are part of the mandatory minimum requirements for all DWSD solicitations, amendments, extensions or renewals of existing contracts. Use this link to access the clearance application: http://bit.ly/detroitclearances

Registration on the City of Detroit (CoD)'s online Supplier Portal is a necessary requirement for DWSD to issue contracts, purchase orders and to receive and pay invoices. Your registration in the portal will enable a seamless award, invoice, and payment experience in conducting business with DWSD.

The portal provides suppliers with:

- Access to awarded PO's;
- Ability to electronically submit invoices against appropriate purchase orders; and
- Streamlines payment.
